Proposal Submission Deadline: June 17, 2015

The Department of Economic Opportunity (DEO), Division of Community Development is currently soliciting proposals for Fiscal Year 2015 - 2016 Community Planning Technical Assistance Grants. Grants awards will be based on project scope and merit. Projects must be completed by May 31, 2016.

Eligibility

Community Planning Technical Assistance grants are available to counties and municipalities. Regional Planning Councils may also be eligible for projects at a regional scale that include more than one county. All proposed projects must be related to implementation of the Community Planning Act. Communities that are selected to participate in the Competitive Florida Partnership, an enhanced technical assistance opportunity, are not eligible to receive a separate Community Planning Technical Assistance Grant, However, communities are encouraged to apply for both as only a limited number of communities will be eligible for the Competitive Florida Partnership.

Local Government Proposal

Interested local governments are to submit a letter of request and a proposed scope of work to DEO. The request should identify:

- The project and its importance to the community:
- The total amount of funding requested: and
- The product that would be produced as a result of receiving funding.

Scope of Work

The scope of work submitted with the letter of request must be in a table format and must describe:

- 1. The deliverables, which are the specific work to be done, for example, "hold advertised public workshop to review draft future land use element
- 2. The deliverable due date (the date the deliverable will be received by DEO).
- 3. Performance measures, which are the documentation that will be provided to DEO to demonstrate that the work described in the deliverable has been completed. For the deliverable example provided above, the performance measures would be "a copy of the advertisement for the public workshop, a copy of the minutes of the public workshop, and a copy of the draft future land use element amendments presented at the workshop in strike through and underline format.
- 4. The payment amount requested for each deliverable.

- City of LaBelle Scope of Work Farm Tour.
- Deerfield Beach Scope of Work Complete Streets Implementation Plan.
