PROJECT DESCRIPTION

Hebni Nutrition Consultants, Inc. (Hebni) is a community-based, not for profit (501 (c)(3)) agency formed in 1995 to educate high-risk, culturally diverse populations about nutrition strategies to prevent diet-related diseases. Hebni's mission is to provide culturally appropriate nutrition education and intervention strategies to prevent diet-related diseases.

The target populations for Hebni's services are minorities at risk for obesity, heart disease, diabetes, cancer, stroke and obesity. Hebni has partnered with local churches, schools, community centers, local housing authorities, city and county leaders, and local community-based organizations to bring culturally appropriate nutrition education to at-risk minority populations living in 32805 and surrounding neighborhoods. Hebni has developed several programs aimed at reducing poor health outcomes for African-Americans in the Central Florida community. In 2007, with a \$250,000 Community Development Block Grant from the City of Orlando, Hebni built a Nutrition Resource Center (NRC) which is located in the heart of 32805 zip code area of Orlando. The NRC is equipped with four state-of-the-art commercial test kitchens, classroom space, conference rooms, and a nutrition resource library. Hebni offers easy access to nutrition education programs, free health screenings, healthy cooking classes, and nutrition counseling from African-American registered dietitians. Since 2009, more 900 youth and adults have participated in nutrition workshops and healthy cooking classes. Hebni also collaborates with the Orange County Health Department, City of Orlando, Get Active Orlando, the Orlando Housing Authority, Orange County Public Schools, Teen Express, Boys and Girls Club, and other community-based organizations to provide cooking demonstrations and nutrition education classes. The NRC serves as a catalyst to provide nutrition and health information to Orange County's highest-risk population.

Hebni is about to embark on a new program titled **Fresh Stop**. Fresh Stop will assist with filling a void of existing Food Deserts in Central Florida. This summer Hebni will launch the first Mobile Farmers Market that will be equipped with produce on a repurposed donated Lynx bus.

Hebni request to City of Orlando: The wear and tear of our current space could use a new coat of paint and repairs to settlement cracks on the building. The last paint job was donated by Harden Construction during the course of the renovations. Hebni is requesting support to fix stucco cracks, settlement cracks, minor rusting, restriping driveway, fresh awning coverings, window coverings (wrap) designs to demonstrate our services on the window and a new paint job on the building. The cost for this project is \$ 12,050.00. This fee includes supplies, materials, and labor involved.
