

1 AN ORDINANCE OF THE CITY COUNCIL OF THE CITY  
2 OF ORLANDO, FLORIDA, RELATING TO CHAPTER 29,  
3 ORLANDO CITY CODE, "GAS CODE" BY AMENDING  
4 SECTION 29.01 TO REFLECT COMPLIANCE WITH THE  
5 FLORIDA BUILDING CODE FUEL GAS CODE AND  
6 PROVIDING FOR SEVERABILITY, CODIFICATION,  
7 CORRECTION OF SCRIVENER'S ERRORS, AND AN  
8 EFFECTIVE DATE.

10 NOW, THEREFORE, BE IT ENACTED BY THE CITY COUNCIL OF THE  
11 CITY OF ORLANDO, FLORIDA:

13 SECTION 1. CHAPTER 29, AMENDED. Chapter 29, Code of the City of Orlando,  
14 Florida, is hereby amended as follows:

16 Sec. 29.01. - Adoption of ~~Standard-Florida Building Code Fuel~~ Gas Code.

17 ~~The Standard Gas Code, 1997 Edition, including appendices thereto, except and not~~  
18 ~~including Section 108, and Appendices "B" and "C," all of which are hereby deleted, is hereby~~  
19 ~~adopted as the Gas Piping, Appliances and Installation Code of the City. Said Code shall be~~  
20 ~~construed as comprising this Chapter and shall consist of a separate volume which is hereby~~  
21 ~~designated as the "Gas Piping, Appliances and Installation Code of the City of Orlando" to which~~  
22 ~~reference is hereby made. Such Code may be cited in the alternative as "Chapter 29 of the Code~~  
23 ~~of the City of Orlando." One copy of said Code is on file with the City Clerk for public use,~~  
24 ~~inspection and examination.~~ All gas plumbing work shall be performed in accordance with the  
25 most recently adopted version of the Florida Building Code Fuel Gas Code as updated by the  
26 Florida Building Commission, and as may be amended thereby.

28 SECTION 2. SEVERABILITY. If any provision of this ordinance or its application to  
29 any person or circumstance is held invalid, the invalidity does not affect other provisions or  
30 applications of this ordinance which can be given effect without the invalid provision or  
31 application, and to this end the provisions of this ordinance are severable.

33 SECTION 3. CODIFICATION. The City Clerk and the City Attorney shall cause the  
34 Code of the City of Orlando, Florida, to be amended as provided by Section 1 of this ordinance  
35 and may renumber, re-letter, and rearrange the codified parts of this ordinance if necessary to  
36 facilitate the finding of the law.

38 SECTION 4. SCRIVENER'S ERROR. The City Attorney may correct scrivener's  
39 errors found in this ordinance by filing a corrected copy of this ordinance with the City Clerk.

41 SECTION 5. EFFECTIVE DATE. This ordinance takes effect immediately upon final  
42 passage.
