Committee Members were advised that Qualification Statements must be independently scored by each Member; that Committee Members should not indicate to the group what scores he/she gives to a particular firm; and that Committee Members must not attempt to influence other Committee Members in their scoring.

The Meeting was turned over to the technical Chair and discussion ensued, and, then, Committee members individually scored/ranked the shortlisted firm according to the criteria outlined in the Request for Qualification Statements.

A motion was made by <u>Ronnie Proulx</u>, and seconded by <u>Paul Deuel</u>, to accept the rankings and to recommend to City Council for authorization for the Chief Procurement Officer (CPO) to negotiate and execute contracts, and all subsequent renewals, for Continuing Contracts with the top <u>five (5)</u> ranked firms. There were no members of the public present. The motion carried unanimously.

A motion was made by <u>Hector Sanchez</u>, and seconded by <u>Byron Raysor</u>, to adjourn at <u>3:13</u> p.m. The motion carried unanimously.
