REPORTS

Ricky Ly reported on his site visit to Primrose Plaza. Mr. Ly reported that the building hosts not only the Families, Parks and Recreation Administration, but the Recreation Administration offices, HOLA offices, as well as a public gym. Ricky noted that the inside of the gym needs a fresh coat of paint. It was recommended that the Central Florida Leadership Academy possibly do a community project in which they will repaint the gym since they are the main user.

David Wagg, Assistant Parks Division Manager, reported on behalf of John Perrone that his staff planted ninety-nine trees over the last month. Mr. Wagg reported that on October 24, 2015 the US Open of Waterskiing will be at Gaston Edwards Parks, the day will be filled with boats and jet skis on display, water sports vendors, as well as food. Some upcoming events include the Moroccan Festival on November 8, 2015 at Festival Park; Beer Fest on November 14, 2015 at Festival Park wherein attendees will be able to sample craft and premium beers from local breweries and around the world. In closing, Mr. Wagg reported that on October 31, 2015 the City of Orlando will be holding the first mountain bike park ribbon cutting at Lake Druid Park.
