




The Public Test of Voting Tabulation Equipment began at 10:00 a.m. with Orange County Supervisor of Elections staff members Luis Torres and Tom Dougherty briefing those in attendance on the testing procedure for the machines scheduled to be used in the November 3, 2015 City of Orlando General Election. The City Clerk randomly selected ten machines (nine precincts and one Early Voting machine) for testing and the Canvassing Board members selected test decks of ballots for precincts representative of all the ballot styles. SOE staff members tested those ten machines, as well as an Express Vote (accessible) machine in the presence of the members of the Canvassing Board. The Canvassing Board members reviewed the results of the tests and confirmed that in all cases the test results were consistent with the markings on the test deck ballots and the test voting on the Express Vote machine. A test of the DS850 Absentee Ballot Tabulator which will be used for tabulation of the absentee ballots was conducted by Tom Dougherty in the presence of the Canvassing Board. All machines tested as expected. The Canvassing Board members reviewed the test result tapes and confirmed by their initials or signatures on the tape print-outs and on the Public Test Results Summary (attached) that the results were accurate. The Supervisor of Elections staff sealed the test deck for the DS850 into a storage case and the Canvassing Board members signed the seal. The same test deck will be used to perform the post-election tests on the DS850 Absentee Ballot Tabulator. The Public Test concluded at 11:06 a.m.
