## DESCRIPTION

COMMENCE at the intersection of the East Right of Way line of S Parramore Avenue and the South Right of Way line of W Central Boulevard, also being the northwest corner of Lot 1, Sellers Central Avenue Sub-division as recorded in Plat Book G, page 88 of the Public Records of Orange County, Florida; thence $\mathrm{N} 89^{\circ} 51^{\prime} 59^{\prime \prime} \mathrm{E}$ along said South Right of Way line, a distance of 237.29 feet for a POINT OF BEGINNING: Thence continue N8951'59"E along said South Right of Way line a distance of 10.00 feet; thence departing said South Right of Way line; run $S 00^{\circ} 00^{\prime} 00^{\prime \prime} \mathrm{W}$ a distance of 48.53 feet to a point of curvature of a curve, concave easterly, having a radius of 95.00 feet, a central angle of $15^{\circ} 25^{\prime} 21^{\prime \prime}$ and a chord distance of 25.49 feet that bears $\mathrm{S} 07^{\circ} 42^{\prime} 40^{\prime \prime} \mathrm{E}$; thence southeasterly along the arc of said curve a distance of 25.57 feet; thence $\mathrm{S} 15^{\circ} 25^{\prime} 21^{\prime \prime} \mathrm{E}$ a distance of 33.53 feet to a point of curvature of a curve concave westerly, having a radius of 105.00 feet, a central angle of $15^{\circ} 09^{\prime} 51^{\prime \prime}$ and a chord of 27.71 feet that bears $507^{\circ} 50^{\prime} 26^{\prime \prime} E$; thence along the arc of said curve a distance of 27.79 feet; thence S00 ${ }^{\circ} 15^{\prime} 30^{\prime \prime} \mathrm{E}$ a distance of 478.21 feet to a point on the North Right of Way line of W Church Street; thence S89 ${ }^{\circ} 43^{\prime} 48^{\prime \prime} \mathrm{W}$ along said North Right of Way line a distance of 10.00 feet; thence departing said North Right of Way line, run $N 00^{\circ} 15^{\prime} 30^{\prime \prime} \mathrm{W}$ a distance of 478.21 feet to a point of curvature of a curve, concave westerly, having a radius of 95.00 feet, a central angle of $15^{\circ} 09^{\prime} 51^{\prime \prime}$ and a chord of 25.07 feet, that bears $N 07^{\circ} 50^{\prime} 26^{\prime \prime} \mathrm{W}$; thence northwesterly along the arc of said curve a distance of 25.14 feet; thence $\mathrm{N} 15^{\circ} 25^{\prime} 21^{\prime \prime} \mathrm{W}$ a distance of 33.53 feet to a point of curvature of a curve concave easterly, having a radius of 105.00 feet, a central angle of $15^{\circ} 25^{\prime} 21^{\prime \prime}$ and a chord of 28.18 feet, that bears $N 07^{\circ} 42^{\prime} 40^{\prime \prime} \mathrm{W}$; thence northwesterly along the arc of said curve a distance of 28.26 feet; thence $N 00^{\circ} 00^{\prime} 00^{\prime \prime} \mathrm{E}$ a distance of 48.53 feet to the POINT OF BEGINNING.

Containing $6,136.17$ square feet, 0.141 acres, more or less.
