Kyle Reynolds, Board Administrator, presented the new software system, Novus BoardView, to the board and provided a brief overview of how to operate the software.


8. Presentation of New Inquiries


Sergeant Robert Bear, Internal Affairs, mention that three new cases will be provided at a later date.
