Item C-8 Accepting Meeting Minutes and Approving the Actions of the Municipal Planning Board for the Meeting of January 19, 2016, for item #13 only – The Yard @ Crossman Site (GMP2015-00049, ZON2015-00048, MPL2015-00033, and CUP2015-00014).

Hearings/Ordinances/2<sup>nd</sup> Read #1 Adopting Ordinance 2016-25 Amending the Growth Management Plan to Change the Future Land Use Designation from Industrial to Mixed Use Corridor-Medium Intensity and Rezoning from I-G/T to MU-1/T for property located to the north of Brookhaven Drive, east of Alden Road, south of Virginia Drive and west of Ferris Avenue (The Yard-Crossman).
