Public Comment:

Amanda Gifford appeared to speak on the following item:

Accepting Item #15 of the Meeting Minutes and Approving the Actions of the Municipal Planning Board for the Meeting of May 17, 2016 for Case #SUB2016-00019.

Ms. Gifford spoke as Counsel on behalf of Crooked Lake Renovations, LLC, which owns the property in question. She asked that City Council overturn the Municipal Planning Board's denial to revert to plat at 424 Delaney Park Drive.

Keith Ori also spoke in favor of City Council overturning the Municipal Planning Board's denial.

Mayor Dyer asked Planning Division Manager Dean Grandin to speak about the issue. Mr. Grandin stated that City staff stands by MBP's decision to deny. Commissioner Sheehan also spoke and indicated that she also agreed with the MPB decision regarding this property which is in her district.
