Mayor Dyer called the meeting to order at 1:24 p.m.

## **Public Comment:**

Jose Datil Colon, appearing on his own behalf, spoke about the Pulse tragedy and thanked OPD SWAT and the City of Orlando for their work done in the crisis.

## **Consent Agenda:**

Commissioner Patty Sheehan – District 4 – Commissioner Sheehan indicated that she had no concerns regarding the agenda. She thanked City staff for their work during the Pulse tragedy and the aftermath. She commented on federal gun laws and their impact on local governments and thanked OPD for its work on the peaceful Black Lives Matter march, which occurred after the Dallas police shooting. Commissioner Sheehan also thanked Mayor Dyer for a balanced budget for FY 2016-2017.

Commissioner Regina I. Hill – District 5 – Commissioner Hill indicated that she had no concerns regarding the agenda. She thanked the Finance team as well as Mayor Dyer for his leadership on the FY 2016-2017 budget and the importance of reserve funds in the budget. She thanked Chief Mina and OPD for walking side by side with the marchers in the Black Lives Matter movement.

**Commissioner Samuel B. Ings – District 6** – Commissioner Ings had two concerns with the agenda. On Item H-2 Approving Award of 2016-2017 Intimate Violence Enhanced Service Team (InVEST) Grant, he inquired where the grant money was coming from and asked to speak to CAO Byron Brooks and Police Chief John Mina.

On Item F-1 approving the City of Orlando Housing and Community Development Department 2016-2020 Consolidated Plan and related documents, Commissioner Ings expressed concern about public awareness of the process. He asked about advertising notice in the *Orlando Times* and *Onyx* magazine. Mayor Dyer asked Housing and Community Development Director Oren Henry to meet with Commissioner Ings.

On Item Hearings/Ordinances/2<sup>nd</sup> Read #2 adopting Ordinance No. 2016-53 annexing property located west of Turkey Lake Road, north of Sand Lake Road and east of Spring Lake (Majorca), Commissioner Ings asked about the status of this item and Mayor Dyer indicated that at the 2:00 P.M. City Council meeting, he will ask for the item to be deferred the item to the August 29, 2016 City Council meeting.

**Commissioner Jim Gray – District 1** – Commissioner Gray indicated that he had no concerns regarding the agenda.

**Commissioner Tony Ortiz – District 2 –** Commissioner Ortiz indicated that he had no concerns regarding the agenda.
