

Commence at Southwest Corner of Section 25, Township 23 South, Range 30 East, Orange County, Florida; thence South 89*55'13" East, a distance of 2652.64 feet along the South line of said Section 25; thence departing said South line North 00*06'52" West, a distance of 33.00 feet to a point on the North Right of Way line of McCoy Road (a 66.00 foot wide Right of Way per County Road Project No. 72) and for a POINT OF BEGINNING; thence North 89*55'13" West, a distance of 875.27 feet along said North Right of Way line to a point on a line 1600.00 feet West of and parallel to the centerline of Narcoossee Road (Right of Way varies per City of Orlando Right of Way line of Narcoossee Road; thence along said Westerly Right of Way line the following seven (7) courses and distances: South 30*09'21" East, a distance of 258.95 feet; thence South 21*30'35" East, a distance of 27.47 feet to a point on a non-tangent curve concave Southwesterly, having a radius of 2790.79 feet, a central angle of 05*57'28" and a chord bearing of South 26*37'32" East; thence from a tangent bearing South 29*36'16" East, southeasterly 290.19 feet along the arc of said curve; thence South 23*34'06" East, a distance of 25.00 feet; thence South 09*51'18" East, a distance of 39.47 feet to a point on a non-tangent curve concave Northwesterly, having a radius of 2948.79 feet, a central angle of 04*12'16" and a chord bearing of South 26*58'29" East; thence from a tangent bearing South 24*52'21" East, Southeasterly 290.19 feet along the arc of said curve to a point of reverse curvature of a curve concave Northwesterly, having a radius of 55.00 feet; thence Southwesterly along the arc of said curve, through a central angle of 114.43 feet to the point of tangency of said curve, said point on the aforementioned North Right of Way line of McCoy Road; thence North 89*52'01" West, a distance of 531.68 feet along said North Right of Way line to the POINT OF BEGINNING.

All platted utility easements shall provide that such easements shall also be easements for the construction, installation, maintenance, and operation of underground cable utility services; provided, however, no such construction, installation, maintenance, and operation of cable television services shall interfere with the facilities and services of an electric, telephone, gas, or other public utility. In the event a cable television company damages the facilities of a public utility, it shall be solely responsible for the damages.
- 4. All lot lines intersecting curves are radial unless otherwise noted.
