
#### **DESCRIPTION:**

That part of Section 25, Township 24 South, Range 30 East, Orange County, Florida, described as follows:

Commence at the Easternmost Corner of Laureate Boulevard, according to the plat of LAUREATE BOULEVARD PHASE 10, as recorded in Plat Book 81, Pages 121 and 122 of the Public Records of Orange County, Florida, thence run the following courses and distances along the Northerly right-of-way line of said Laureate Boulevard: N58°42'51"W, 240.00 feet; N57°02'50"W, 412.00 feet to the point of curvature of a curve concave Southwesterly having a radius of 800.00 feet and a chord bearing of N62°55'45"W; thence Northwesterly along the arc of said curve through a central angle of 11°45'50" for a distance of 164.25 feet to the point of compound curvature of a curve concave Southerly having a radius of 1780.00 feet and a chord bearing of N70°18'46"W; thence Westerly along the arc of said curve through a central angle of 03°00'13" for a distance of 93.31 feet to a non-tangent line; thence departing said Northerly right-of-way line run N00°00'16"W, 618.46 feet to the POINT OF BEGINNING; thence N89°59'44"E, 156.53 feet to the point of curvature of a curve concave Southerly having a radius of 718.00 feet and a chord bearing of S80°50'10"E; thence Easterly along the arc of said curve through a central angle of 18°20'12" for a distance of 229.78 feet to the point of tangency; thence S71°40'04"E, 334.18 feet; thence N18°19'56"E. 107.11 feet to the point of curvature of a curve concave Easterly having a radius of 730.00 feet and a chord bearing of N18°26'45"E; thence Northerly along the arc of said curve through a central angle of 00°13'39" for a distance of 2.90 feet to a non-tangent line; thence N71°40'04"W, 178.23 feet; thence S18'19'56"W, 46.00 feet; thence N71'40'04"W, 155.96 feet to the point of curvature of a curve concave Southerly having a radius of 782.00 feet and a chord bearing of N80°50'10"W; thence Westerly along the arc of said curve through a central angle of 18°20'12" for a distance of 250.27 feet to the point of tangency; thence S89°59'44"W, 156.53 feet; thence S00°00'16"E, 64.00 feet to the POINT OF BEGINNING.
