17 18	SECTION 1. SECTION 3, AMENDED. Section 3 of City of Orlando Ordinance

20	SECTION 3. TEMPORARY MORATORIUM. Beginning on the
20	effective date of this ordinance and continuing through December 31,
22	<del>2016June 30, 2017</del> , or sooner if provided pursuant to section 4 of this
23	ordinance, a moratorium is hereby imposed on the opening of new
24	cannabis dispensaries and low-THC cannabis dispensaries and on the
25	expansion or relocation of existing cannabis dispensaries and low-THC
26	cannabis dispensaries.

28	a. During the moratorium, it is unlawful and a violation of
29	this ordinance for any person, firm, or corporation to
30	open or cause to be opened any cannabis dispensary or
31	low-THC cannabis dispensary within the City of
32	Orlando, except that low-THC cannabis dispensaries
33	already approved by official determination of the city
34	zoning official may open and conduct business in
35	accordance with the official determination.

37	b. During the moratorium, it is unlawful and a violation of
38	this ordinance for any person, firm, or corporation to
39	relocate or cause to be relocated any cannabis
40	dispensary or low-THC cannabis dispensary within the
41	City of Orlando.

44	this ordinance for any person, firm, or corporation to
45	expand or cause to be expanded any cannabis
46	dispensary or low-THC cannabis dispensary within the

48	term "expand" means to "enlarge the physical size of."

50	SECTION 2. SECTION 4, AMENDED. Section 4 of City of Orlando Ordinance
51	No. 2016-58 is hereby amended as follows:

53	SECTION 4. EXPIRATION OF THE TEMPORARY
54	MORATORIUM. The temporary moratorium imposed by section 3 of this
55	ordinance expires as of the earliest of the following occurrences:

62	SECTION 3. SECTION 5, AMENDED. Section 5 of City of Orlando Ordinance
63	No. 2016-58 is hereby amended as follows:

65	SECTION 5. RECOMMENDATIONS FOR LAND
66	<b>DEVELOPMENT REGULATIONS.</b> The planning official is hereby
67	directed to study, develop, and recommend land development regulations
68	for cannabis dispensaries and low-THC cannabis dispensaries in the City
69	of Orlando, with such recommendations being delivered to the Orlando
70	City Council by no later than <del>DecemberJune</del> 1, <u>20176</u> .

72	SECTION 4. SEVERABILITY. If any provision of this ordinance or its
73	application to any person or circumstance is held invalid, the invalidity does not affect
74	other provisions or applications of this ordinance which can be given effect without the
75	invalid provision or application, and to this end the provisions of this ordinance are
76 77	severable.
77 78	SECTION 5. REPEAL. All ordinances, resolutions, official determinations or
78 79	parts thereof previously adopted or entered by the city or any of its officials and in
80	conflict with this ordinance are hereby repealed to the extent inconsistent herewith.

82	SECTION 6. SCRIVENER'S ERROR. The city attorney may correct scrivener's
82 83	errors found in this ordinance by filing a corrected copy of this ordinance with the city
