LAKE NONA WASTEWATER TREATMENT FACILITY PHASE 1

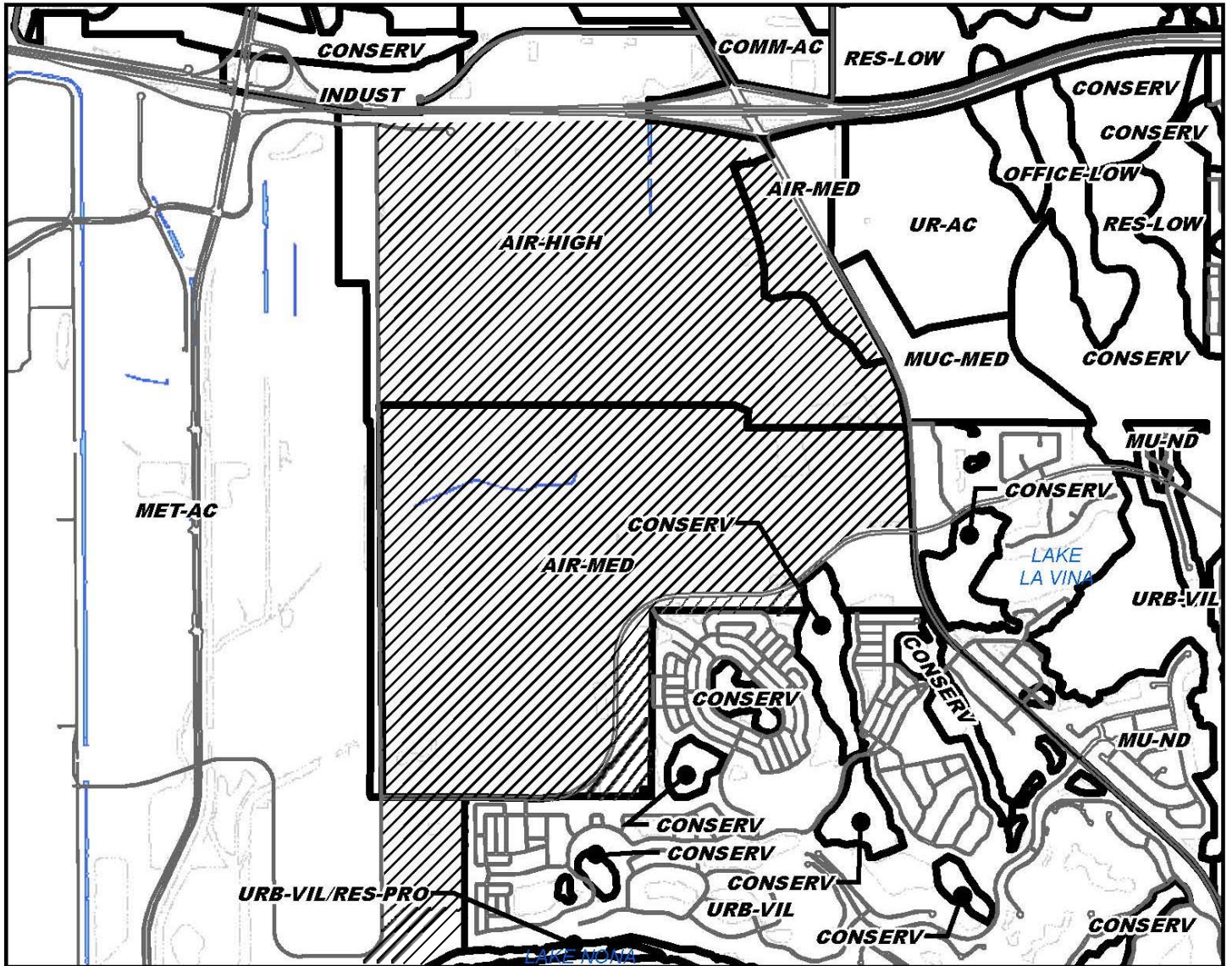
Part of Section 11, Township 24 South, Range 30 East, Orange County, Florida,

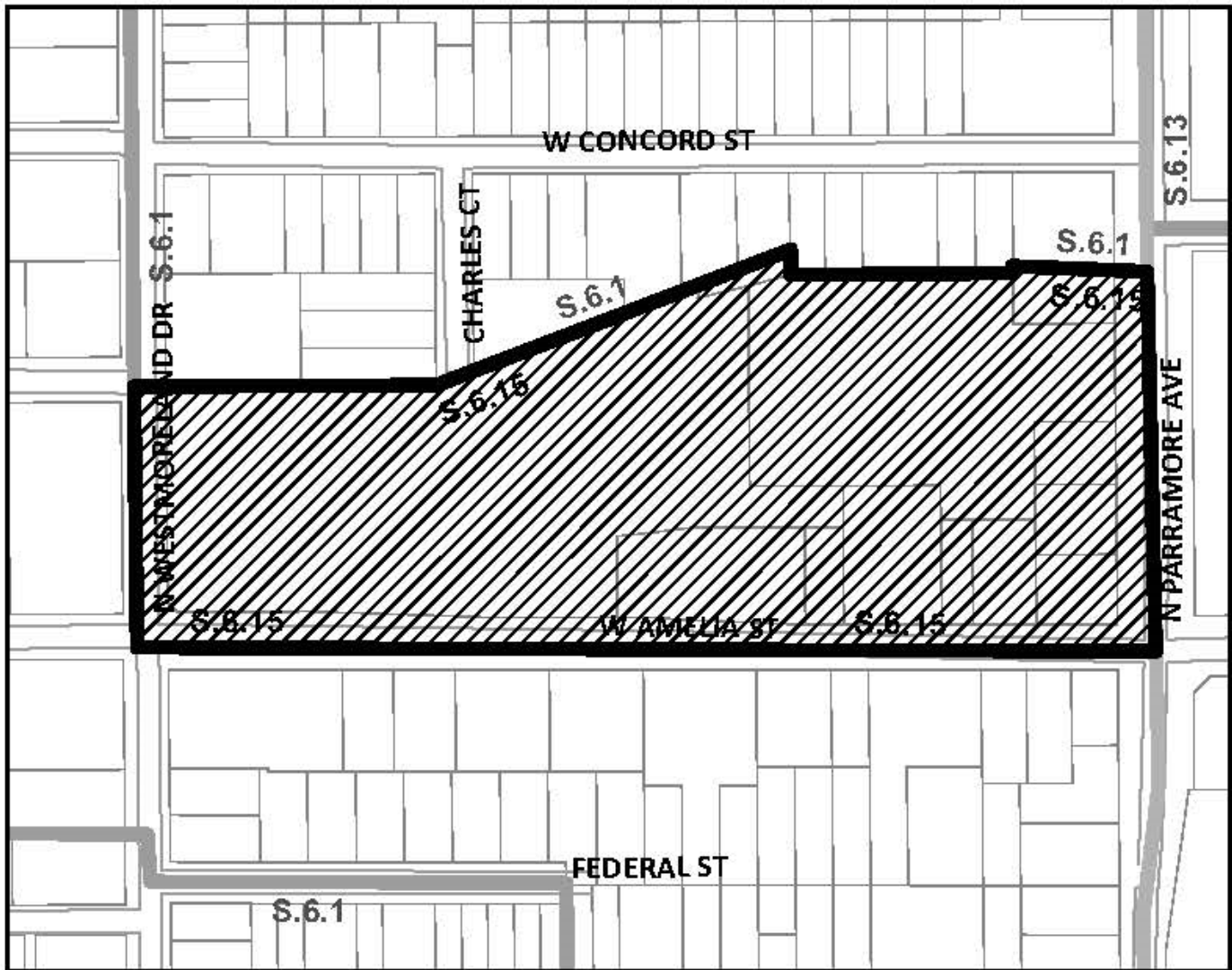

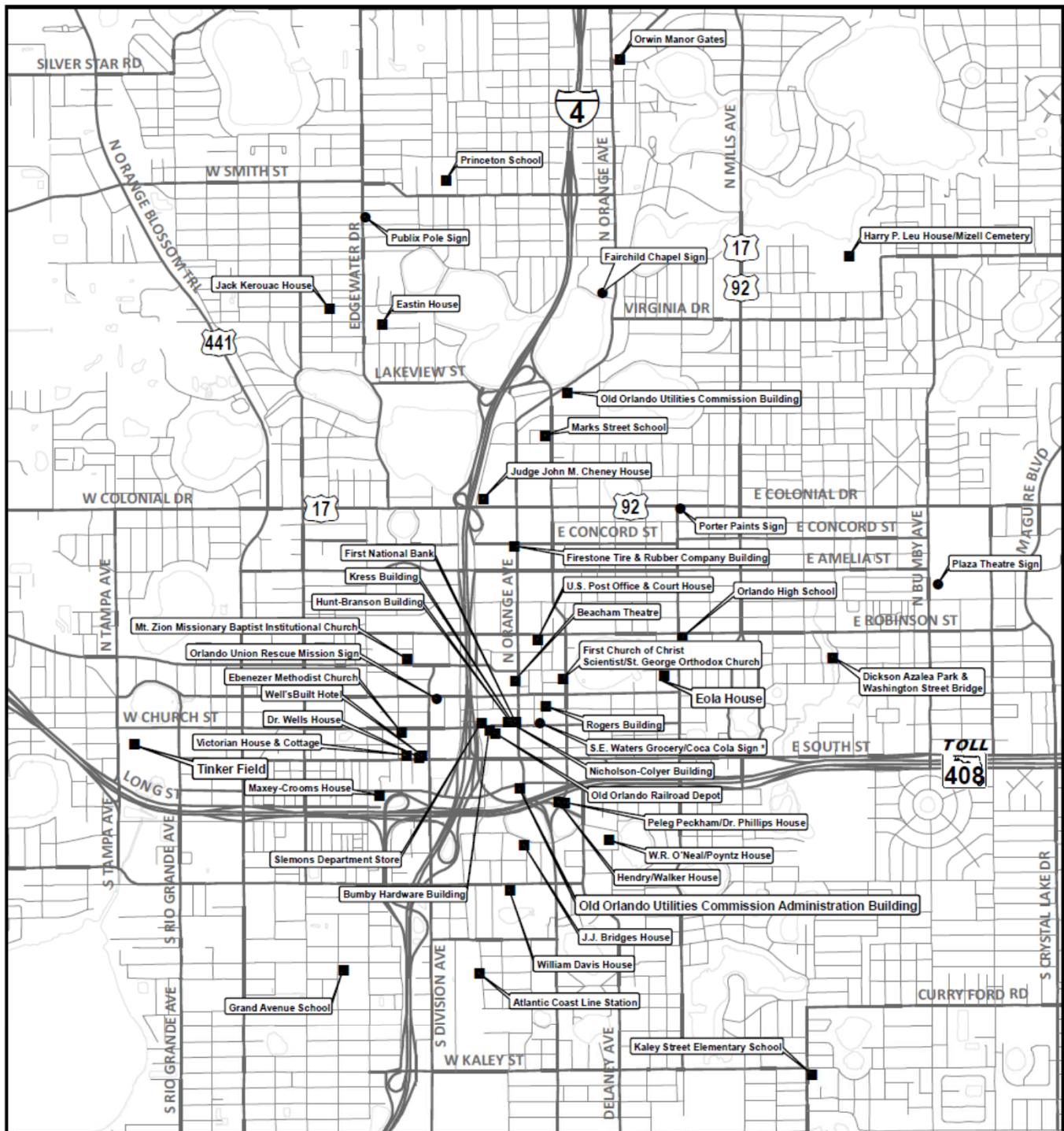


Future Land Use - Proposed GMP2016-00019

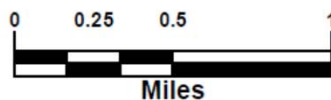
