PABC plans to create 6 new full-time jobs through this project. Total capital investment for this project is approximately \$550,000.

Total eligible fees for PABC under the Business Assistance Program, are \$16,070.59. The BAP will pay fifty percent of eligible fees (\$8,035.30). The fee breakdown is as follows: Transportation Impact Fee @ 50% = \$727.30, Sewer Benefit Fees @ 50% = \$7,308.
