Mayor Dyer called the meeting to order at 11:04 a.m.

Public Comment: No members of the public appeared for public comment on the consent agenda.

Consent Agenda:

Commissioner Jim Gray, District 1 – Commissioner Gray indicated that he had no concerns regarding the agenda.

Commissioner Tony Ortiz, District 2 – Commissioner Ortiz indicated that he had no concerns regarding the agenda.

Commissioner Robert F. Stuart, District 3 - Commissioner Stuart indicated that he had no concerns regarding the agenda, and wanted the Council to be aware that he received a complaint about noise resulting from the Monster Jam event held over the weekend at the stadium.

Commissioner Patty Sheehan, District 4 – Commissioner Sheehan expressed concern over the verbiage change in the second reading of Ordinance No. 2016-98, relating to the Downtown South Neighborhood Improvement District, specifically amending the eligibility requirements for membership on the DSNID Advisory Council. Mr. Shephard indicated that although the language has been changed between readings, the change is minor and it will still allow for the two boards to work together.

Commissioner Regina I. Hill, District 5 – Commissioner Hill expressed concern over Ordinance No. 2017-3 relating to the designation of Orlando historic landmarks. She was particularly concerned over the preservation of landmarks in the Parramore area during the

upcoming redevelopment of the area. She requested a deferral of the reading in order to properly create a plan to secure those areas from being touched.

Mayor Dyer noted that Commissioner Sheehan faced a similar issue when her redistrict was under redevelopment. He asked if Commissioner Hill was comfortable moving the ordinance forward on first reading if they were able to review Parramore historic properties prior to second reading. Commissioner Sheehan commented that her area ended up with higher land values with the historic landmarks. Commissioner Stuart also added that this was done in College Park and, as a result, a variety of types of historic landmarks were identified.

There being no further discussion, the meeting was adjourned at 11:12 a.m.
