AFFORDABLE HOUSING ADVISORY COMMITTEE

I. PURPOSE

A. MISSION STATEMENT. The mission of the Affordable Housing Advisory Committee is to review established policies and procedures, ordinances, land development regulations and adopted local comprehensive plans, and make recommendations to encourage or facilitate affordable and attainable housing.

II. ADMINISTRATION

- A. STAFF. The City provides staff support and administration for the Affordable Housing Advisory Committee. Key staff are as follows:
 - 1. Arancha Lattanzio, Planner II
 - 2. Lisa Pearson, Assistant City Attorney
 - 3. Jeremy Fristoe, Executive Assistant

B. STAFF CHANGES.

 Arancha Lattanzio ceased working for the Housing & Community Development Department and stepped down as Staff Liaison for the Affordable Housing Advisory Committee on July 1, 2016.

III. BOARD MEMBERS

- A. NUMBER. The Affordable Housing Advisory Committee has eleven (11) members which are recommended to the Mayor for appointment by the Nominating Board, appointed by the Mayor, and confirmed by City Council.
- B. REQUIREMENTS. As stated by §420.9076 of the State Housing Initiatives Partnership Act, the Committee must include:
 - 1. One citizen who is actively engaged in the residential home building industry in connection with affordable housing.
 - 2. One citizen who is actively engaged in the banking or mortgage industry in connection with affordable housing.
 - 3. One citizen who is a representative of those areas of labor actively engaged in home building in connection with affordable housing.
 - One citizen who is actively engaged as an advocate for lowincome persons in connection with affordable housing.
 - One citizen who is actively engaged as a for-profit provider of affordable housing.
 - 6. One citizen who is actively engaged as a not-for-profit provider of affordable housing.
 - 7. One citizen who is actively engaged as a real estate professional in connection with affordable housing.
 - 8. One citizen who actively serves on the local planning agency pursuant to §163.3174. If the local planning agency is comprised of the governing board of the county or municipality, the governing board may appoint a designee who is knowledgeable in the local planning process.



- 9. One citizen who resides within the jurisdiction of the local governing body making the appointments.
- 10. One citizen who represents employers within the jurisdiction.
- 11. One citizen who represents essential services personnel, as defined in the local housing assistance plan.
- C. ATTENDANCE. The annual attendance report is attached.
- D. TERMS. Term lengths are three years each and no member may serve more than three consecutive terms.
