

ANNUAL REPORT FISCAL YEAR 2015-16

I. PURPOSE

A. THE VEHICLES FOR HIRE APPEAL BOARD shall act as advisor to the Mayor and City Council on matters concerning the Vehicle-for-Hire industry and services, and shall also act upon directives of the administration or City Council. The Board has the power to adopt rules and regulations to govern its operations and activities so long as such rules and regulations are consistent with the Chapter. The Board has authority to hear appeals from an administrative decision or interpretation of the Towing Enforcement Administrator and Officers. The Board has the discretion to modify the limitations imposed by Section 55.29(4) of this Chapter only when extraordinary circumstances exist to show the applicant is not a danger to the riding public. Providing the applicant meets the burden imposed by Section 55.29(5) of this Chapter. All decisions by the Board are final and binding unless appealed to City Council.

II. ADMINISTRATION
