### **Invocation**

The invocation was delivered by Donna Dowless, artist and Orlando's "Ambassador of Love," followed by the Pledge of Allegiance led by Mayor Buddy Dyer.

### **Commissioner Ortiz's absence**

Mayor Dyer noted that Commissioner Tony Ortiz's father died earlier this year and Commissioner Ortiz is with his family in Puerto Rico to lay his father to rest and, therefore, unable to attend today's Council meeting.

### **Awards/Presentations/Recognitions**

#### **Proclaiming February as Black History Month 2017**

Mayor Dyer called on Chief Service Officer Marcia Hope Goodwin who explained that Black History Month is an annual national celebration recognizing Black Americans for their achievements and significant contributions to society. She thanked Bank of America Senior Vice President Kathy Brown Butler for their event sponsorship, and recognized members from the Mayor's Martin Luther King, Jr.'s Commission, WUCF Central Florida PBS, Dr. Phillips Center for the Performing Arts, Mennello Museum Executive Director Shannon Fitzgerald, City of Orlando Public Art Advisory Board members, Commissioner Regina I. Hill and Commissioner Samuel B. Ings for their work on and support of Black History Month events. Mayor Dyer read the proclamation.

### **Public Arts Events**

Mayor Dyer called on Mennello Museum Executive Director Shannon Fitzgerald for a brief overview of recent public arts events. Ms. Fitzgerald spoke about the success of the Mennello Museum's exhibition opening of Bo Bartlett's paintings and his artist lecture in January and the Indie Folk Fest held on the Mennello Museum grounds on February 11, 2017 with over 5,000 people attending.

### **Mayor's Update**

#### **Smart City Council Designation and Automated Vehicle Pilot Designation**

Mayor Dyer shared that the Smart Cities Council announced that Orlando is one of five cities the Council will partner with as part of the 2017 Smart Cities Council Readiness Challenge. Orlando was selected because of its commitment to using smart technologies to advance livability, workability and sustainability. In addition to this, the U.S. Department of Transportation announced last month that Orlando has been selected as one of ten Automated Vehicle (AV) Proving Grounds, making Central Florida one of the nation's premier clusters for research and development of automated vehicle technology. Mayor Dyer thanked partners in government, education and private industry that, together with City staff, helped make these efforts a reality.

### **Blues B-Q**

Mayor Dyer invited everyone to attend the 11th annual Blues B-Q on Saturday, February 18, 2017 in Downtown Orlando. The free event features two stages on the City Hall Plaza, with live performances from The Fabulous Thunderbirds, Robert Randolph, The Family Band and more.

Mayor Dyer announced that Interim City Clerk and Chief Assistant City Attorney Amy Iennaco is retiring on April 1, 2017 with 26 years of service, and thanked Amy for her dedication, professionalism and commitment to Orlando. To meet the ongoing needs of Pulse victims and based on recommendations from the U.S. Department of Justice, a new Manager of Collaborative Partnerships position has been created to provide ongoing support to the victims of the Pulse tragedy. Mayor Dyer announced that Felipe Sousa Rodriguez has been hired for this position and he will be the main point of contact within the City on all issues related to the Orlando United Assistance Center. This position will work closely with United Way and mental health and social service providers to remove barriers and ensure survivors have access to a variety of services and support which will nurture hope, strength, health and healing.

This item will further the City's efforts to revitalize the Mercy Drive neighborhood through a community visioning process.
