Katherine Page representing the Mennello Museum of American Art came before the Board to seek funding for the upcoming "3rd Annual Indie Folk Festival" on February 11, 2017 in Loch Haven Cultural Park. The festival is dedicated to music, art, picnic and love in the lakeside Sculpture Garden of the museum. The festival will be held from noon to 5:00 p.m. and will be free to the public. The Valentine's Day themed family picnic features local music, original art vendors plus foodie-friendly goodies and craft beverages for sale. Ms. Page stated that last year there were approximately 4,000 participants and they hope to have about 4,500 this year. A motion was made by Allison Bekavac and seconded by Jason Reynolds to approve funding of \$1,500 for this event. The motion carried unanimously.

Board member Shally Wong of Asia Trend, Inc. came before the Board to seek funding for the annual "Dragon Parade Lunar New Year Festival" to be held on February 11, 2017 to celebrate the City's Asian Culture throughout the Mills 50 Main Street corridor. The event will consist of a parade followed by a festival featuring 45 partners/vendors, an array of performances and delicious Asian cuisine. This has been a very popular event attended by participants from around the state, nation and other countries. Ms. Wong has partnered with the Y.E.S.S. organization and Mills 50 Mainstreet which has received five years of grant funding for the same event in the past.

A discussion ensued among FPR Board members regarding the fact that board rules limit funding to no more than five years for the same organization. While Asia Trend is a different organization than Mills 50 Mainstreet, which has already received 5 years of funding for this same event in the past, concern was expressed that the use of a different organization exposed a "loophole" in FPR Board rules.

After further discussion, a motion was made by Gregory Reynolds to approve funding of \$250. It was seconded by Celeste Thomas. The motion carried with only Ricky Li abstaining due to his relationship with Mills 50 Mainstreet and Asia Trend. Board members agreed to amend the guidelines at the next meeting to close the loophole. Gregory Reynolds volunteered to draft an amendment to this effect, to be placed on the agenda for a vote at the next Board meeting.

# FIGHTING CRIME IN ORLANDO

Ricky Li shared his concerns about recent news of crime in Orlando. After discussion, Greg Reynolds agreed to draft a letter to the Orlando City Council advocating for funding of programs for older youth as part of efforts to reduce youth crime. The letter will be presented to the full Board for a vote at the next meeting.

# SITE VISITS

A list of parks and dates was distributed to Board members; each Board member was asked to select the site s/he will visit and evaluate this year, for reporting back to staff and the Board. Members asked that a projector and laptop be available at future meetings so they can make site visit presentations to the Board.

# **REPORTS**

Lisa Early thanked the Board for their attendance of the Gino Nicolas Memorial unveiling and the Green Up Event earlier in the month. Both events were held at the John H. Jackson Community Center. Ms. Early also reported that Mayor Buddy Dyer's CityKidz! Buddy's Benefit for Children event is being organized this year in support of Parramore Kidz Zone (PKZ). Finally, Ms. Early reported that she will attend the Orange County Legislative Delegation meeting on January 17<sup>th</sup>, to discuss a proposed Amendment to FS 402.301 to exempt municipalities from child care licensure.

Curtis Manning, Dr J.B. Callahan Neighborhood Center Manager, representing the Recreation Division on behalf of Rodney I. Williams, reported on several events, including a Valentine's Day Dance to be held at the Dover Shores Community Center on Tuesday, February 14, 2017 from 3:00 p.m. - 6:00 p.m. Mr. Manning went on to describe programs at the Callahan Center, including after school programs for youth between the ages of 5 and 14, tutoring, athletics and dance. Ms. Early added that the center also houses a Head Start program for preschool aged children. She then introduced Ms. Toinette Stenson, Manager of the Callahan Head Start program, who led a large group of Head Start children into the meeting room. The children sang and performed several songs, followed by cheers from Board members.

There being no further business to discuss, the meeting was adjourned at 12:15 p.m.
