Mayor Dyer called the meeting to order at 10:47 a.m.

**Consent Agenda:**

**Commissioner Patty Sheehan, District 4** – Commissioner Sheehan indicated that she had no concerns regarding the agenda and asked to meet with City Planning Division Manager Dean Grandin.

**Commissioner Regina I. Hill, District 5** – Commissioner Hill indicated that she had no concerns regarding the agenda.

**Commissioner Samuel B. Ings, District 6** – Commissioner Ings indicated he would like to meet with City Planning Division Manager Dean Grandin in reference to Item C-5 (Approving a 9-month Temporary Use Permit with the possibility of a 6-month administrative extension by the Planning Official for temporary gravel parking at 116 America St., generally southwest of the intersection of America St. and Lucerne Terr. (LDC2017-00137). In reference to Item C-6 (Municipal Planning Board as Airport Zoning Commission), Commissioner Ings asked why City Council was not the Airport Zoning Commission and Chief Assistant City Attorney Kyle Shephard advised that the Municipal Planning Board makes recommendations to City Council and City Council makes the final decision which, in effect, makes City Council the Airport Zoning Commission. Commissioner Ings had a question in reference to Item G-1 (Ranking of Firms to Provide Special Inspector for Smoke Control Services for Stage 2 of the Dr. Phillips Center) as to the firms chosen and requested information on M/WBE participation.
