Proclaiming April 2017 as Fair Housing Month

Mayor Dyer called on Chief Service Officer and Director of Community Affairs and Human Relations Marcia Hope-Goodwin who noted that April is Fair Housing Month nationwide and

announced the annual Florida Fair Housing Summit on April 17 and 18, 2017 at the Hyatt Regency Orlando, sponsored in part by the City of Orlando. Mayor Dyer read the proclamation.

Proclaiming April 17-22, 2017 as National Community Development Week

Mayor Dyer called on Housing and Community Development Director Oren Henry who spoke about National Community Development Week, an annual recognition of the numerous accomplishments of the U.S. Department of Housing and Urban Development's Community Development Block Grant (CDBG) program, which provides grants to state and local governments and funds activities such as housing rehabilitation, business assistance, senior services and infrastructure, and the HOME Investment Partnerships program which provides grants to state and local governments to create safe, decent and affordable housing for renters and homeowners. Mr. Henry introduced Chief Financial Officer Victoria Scott and Director of Residential Services Alexis Collins of the Orlando Neighborhood Improvement Corporation and thanked the ONIC for their partnership with the City to complete extensive renovations to the Richard Allen Gardens Apartments using HUD HOME funding while keeping the apartments affordable to the residents. Mayor Dyer read the proclamation.

Proclaiming April 2017 as Volunteer Appreciation Month

Mayor Dyer called on Chief Service Officer Marcia Hope-Goodwin to introduce Volunteer Appreciation Month and thanked the many citizens who volunteer with citizen advisory boards, Orlando Cares, Keep Orlando Beautiful, GreenUp Orlando, Harry P. Leu Gardens, Mennello Museum of American Art, Families, Parks and Recreation programs, Orlando Police Department, Orlando Fire Department, neighborhood associations, Neighborhood Watch organizations, Operation AmeriCorps, O-PASS, AmeriCorps VISTA, My Brother's Keeper, UCF, Heart of Florida United Way, RSVP, Urban League of Central Florida, Public Allies of Central Florida, Teach for America, as well as many others. Ms. Goodwin acknowledged coordinators Hiba George and Giorgina Pinedo for their work with Orlando Cares and AmeriCorps VISTA volunteers and for hosting the Volunteer Appreciation reception earlier today. Mayor Dyer read the proclamation.

Recognizing 2017 Healthy Weight Community Champion

Mayor Dyer called on Families, Parks and Recreation Director Lisa Early to introduce the Healthy Weight Community Champions program. The Community Champions program is part of the Florida Department of Health's Healthiest Weight Florida initiative, a public-private collaboration to help people make consistent, informed choices about healthy eating and active living. Ms. Early introduced Florida Department of Health Orange County Director Dr. Kevin Sherin who presented the Florida Surgeon General's Healthy Weight Community Champion 2017 award to the City. Orlando has been a Healthy Weight Community Champion for four consecutive years and one of sixteen cities named a "Playful City USA," due in part to the City's 47 ball fields, youth sports programs of soccer, football, Little League, basketball, cheerleading, baseball leagues, girls lacrosse, Dragon Boat racing and 47 playgrounds. Orlando's Families, Parks and Recreation Department promotes healthy eating through year-round after school programs in 18 community centers and 8 middle schools, nutrition and healthy cooking education, 16 community gardens and 337 garden plots, with a new 52-plot community garden at Lake Druid with 12 of those plots growing food to be donated back to the schools. The City's Wellness programs, diabetes academy, Know Your Numbers health screening, annual Employee Fitness Challenge and 997 miles of sidewalks offer a wide variety of physical activity. Ms. Early thanked Wellness Coordinator Debbie Castagnola, Sustainability Director Chris Castro, Sustainability Project Manager Ian Jurgensen, FPR's Children and Education Program Manager Brenda March, Recreation Division Manager Rodney Williams, Parks Division Manager John Perrone, After School All Stars program and Economic Development Planner Mary-Stewart Droege for leading the Healthy Weight Community Champion recognition effort.

Proclaiming April 2017 as Water Conservation Month

Mayor Dyer called on Sustainability Director Chris Castro who spoke of the Department of Environmental Protection and local water management districts' initiatives to increase water use efficiency, including energy and water efficiency in buildings. The Department has been working with local governments across Florida to prioritize water conservation and heighten awareness of water conservation during the month of April. Mr. Castro introduced St. Johns River Water Management District Intergovernmental Coordinator Nancy Christman who noted that 50-60% of water use is for irrigating lawns. Careful watering and efficient household use of water is vital to long-term sustainability of the water supply. Ms. Christman thanked the City for its focus on conservation and sustainability. Mayor Dyer read the proclamation.

Mayor Dyer spoke of Frank Attkisson's great leadership and numerous contributions throughout his many years in public service and asked for a moment of silence in Mr. Attkisson's honor to pay tribute to his life and legacy.

Recognition of CAO Byron Brooks and Public Works Director Rick Howard

Mayor Dyer congratulated Chief Administrative Office Byron Brooks on his recent induction into the Clemson University Hall of Fame in the College of Architecture, Arts and Humanities. Mr. Brooks was selected for leadership in his profession and the significant impact he has had in the Orlando community through his role at the City. Mayor Dyer also congratulated Public Works Director Rick Howard who was named one of the Top Ten Public Works Leaders in 2017 by the American Public Works Association. Mr. Howard was recognized for his work on several major initiatives and projects in Orlando.

Last year the City initiated a pilot program with Goodwill Industries of Central Florida to employ homeless individuals in the Streets and Stormwater and Solid Waste divisions. To date, the City has employed 9 crew members through GoodSource, with the intention of transitioning these workers into full-time jobs. This item is a long-term contract with GoodSource Staffing to achieve the City's goal of ensuring that homelessness in the community is rare, brief and one-time.

The City of Orlando is joining the National Recreation and Park Association's Meet Me at the Park initiative which helps make improvements to parks and community centers across the country. One of three City parks and community centers will receive a \$20,000 grant and Orlando residents get to choose which one. Residents can choose from are new fitness equipment at Al Coith Park, a fitness trail at Bill Frederick Park at Turkey Lake or the renovation of basketball courts, a baseball field and multiuse field at the Jackson Neighborhood Center. Hill inquired about corner lot regulations and asked if special circumstances could be incorporated into the ordinance rather than on a case by case basis. Commissioner Tony Ortiz asked about simplifying parking restrictions and asked how many community meetings were held on this matter. Ms. Dang replied there were four city-wide planning board meetings, one evening workshop, two City Council workshops, an online survey and posts on social media and the Next Door website. Commissioner Robert F. Stuart inquired about variance options. Mayor Dyer opened the public hearing and the following persons appeared to testify.
 - 1. Joseph Wheeler, on his own behalf, appeared in opposition to the ordinance.
 - 2. Arlyn Robertson, on his own behalf, appeared in opposition to the ordinance.
 - 3. William Murphy, on his own behalf, appeared in opposition to the ordinance, and submitted a letter dated December 13, 2013 authored by Mark Cechman, AICP, Zoning Official and Dean Grandin, Jr., AICP, Planning Official of the City of Orlando Planning Division in re: Zoning Official's Interpretation Concerning Driveways for Internal Duplex Lots (LDC2013-00438), a copy of which has been filed as supplemental papers to this meeting.
 - 4. David Rose, on his own behalf, appeared in opposition to the ordinance.

At approximately 4:01 P.M. Commissioner Samuel B. Ings left the meeting and returned at 4:03 P.M. Mayor Dyer closed the public hearing and City Council voted 6-1 to adopt the ordinance, filed and documentary #1704101203, noting that Commissioner Tony Ortiz voted "no."

(4) City Clerk Denise Aldridge presented Ordinance No. 2017-3 relating to the designation of Orlando historic landmarks. Commissioner Samuel B. Ings moved and Commissioner Patty Sheehan seconded a motion that the ordinance be adopted on 2nd reading. Mayor Dyer opened the public hearing and no one appeared to testify. Mayor Dyer closed the public hearing and City Council voted unanimously to adopt the ordinance, filed and documentary #1704101204.

19. General Appearances

Rich Black, appearing on behalf of Lake Sunset Luola Terrace, spoke about noise concerns near Camping World Stadium on event dates. He asked City Council to consider assisting senior citizens in the area with obtaining insulated windows for their homes to help muffle noise coming from stadium events and noted that the sound of fireworks, music, etc. is amplified by nearby Lake Sunset. He also spoke about parking concerns in the stadium area, specifically some entrepreneurs offering "secured parking" which has resulted in those parked cars being broken into and ensuing police activity as a result, and asked City Council to consider arranging private security to patrol parking areas during events. He also suggested more camera surveillance in the area and inquired if the cameras already there were operable. Lastly, he suggested the issuance of decals for residents who live in the stadium area to allow for smooth ingress and egress of the neighborhoods. Mayor Dyer noted Mr. Black's noise concerns and suggested working with Green Works and/or Orlando Utilities Commission to look into insulated windows for noise and climate control. Mayor Dyer also noted the security concerns and will consider outside security agencies and is aware of the fraudulent parking operations. Commissioner Regina I. Hill thanked Mr. Black for his leadership in the West Lakes community.

Jose Datil, appearing on his own behalf, spoke about general concerns in the Parramore area.
