OPENING SESSION

- Call to Order at 3:02 p.m. by Mark Cechman, Executive Secretary

J.P. Weesner made a motion to approve the minutes of the April 11, 2017 CVDRC meeting. The motion was seconded by Billy Hattaway and passed 3-0 by unanimous voice vote.

Request for approval of a Specific Parcel Master Plan for Student Housing at Creative Village, located at the northwest corner of Livingston Street and Terry Avenue. The 15-story Student Housing Project will include student housing, education space for UCF and Valencia College, parking and groundfloor retail.

Staff recommends APPROVAL of the Request with Conditions

Craig Ustler, Creative Village Development, LLC and Tim Baker of Baker Barrios Architects gave an informational presentation on the proposed 15-story student housing building. Mr. Ustler stated that they are in full support of the Staff Report and will continue working with Staff to address the Conditions of Approval.

Doug Metzger noted that the Staff was pleased with the building design, and added that Staff will require the architectural elevations will come back to CVDRC for final review prior to vertical building permits, which is common and consistent with the typical Appearance Review Board process.

Discussion ensued regarding ground floor uses, verticality in the design, façade lighting, parking, loading area, top half of building on Terry Ave side, and elevations on west side of the building.

J.P. Weesner made a motion to approve MPL2017-00018 in accordance with the Conditions of Approval in the Staff Report. The motion was seconded by Billy Hattaway. The motion carried unanimously 3-0 by voice vote.
