1. PUBLIC COMMENT

2. APPROVAL OF MINUTES FROM MARCH 2, 2017

A MOTION TO ACCEPT THE MINUTES OF MARCH 2, 2017 was made by Ms. Henry and seconded by Mr. Brown; MOTION CARRIED UNANIMOUSLY.

3. ACTUARIAL PRESENTATION AND SUMMARY

Ms. Laudeman gave a brief presentation explaining the role of an actuary and the information and assumptions examined to compile the valuation. The actuary is governed by Florida State Statute, Chapter 112.64. She reminded the Board the Plan closed in 1998 and has only 126 active members.

Mr. McCullion introduced Mr. Armstrong and turned the meeting over to him. The 2017-2018 fiscal year City contribution will be \$7,880,413 if paid as a lump sum at the beginning of the fiscal year, and reflects a \$0.5 million increase in the City's dollar contribution requirement from the previous year. Mr. Armstrong noted the Plan is now 81% funded.

A MOTION TO ACCEPT THE 2016 ACTUARIAL VALUATION was made by Mr. Rhodes and seconded by Ms. Henry; MOTION CARRIED UNANIMOUSLY. (Mr. Bass left the meeting at 12:01 PM.)

Some general discussion ensued. Ms. Henry left the meeting at 12:11 and Ms. McCrimmon left the meeting at 12:14 PM.
