Thomas C. Chatmon Jr., Executive Director, briefly spoke on the resignation of Jessica Burns from the Board; he also gave a PowerPoint presentation highlighting past and future events around downtown. The Board thanked Mr. Chatmon for his presentation.

New Business:

a. Sponsorship and Marketing Services Agreement with Worth Group, LLC – Thomas C. Chatmon Jr., Executive Director - The Worth Group is an integrated media company that produces content of the highest quality for sophisticated consumers, high net worth individuals, wealth advisors, prominent organizations and world-class brands. Focused on entrepreneurship, wealth management, philanthropy, travel and life's pleasures and passions, content published under the Worth brand is distributed via print, digital, broadcast and radio channels. Beginning with the Q3 2017 issue, Worth will be delivered to a highly curated proprietary database of key influencers at public and private companies, important foundations, endowments and law firms, as well as prominent sports executives and athletes. Additionally, they are expanding market distribution to include five Worth destination hotspots: Atlanta, San Diego, Nashville, Orlando and Las Vegas. Circulation includes high net worth individuals as well as important executives and influencers.

Worth is launching a three year campaign exploring the business of sports. The initiative will highlight how sports can provide for economic growth and unify communities while providing a positive social impact. Worth has recognized Orlando is attracting the world's largest sporting events. Through a strategic partnership, Worth will utilize sports as a vehicle to tell the story of modern Orlando on a national level. The City of Orlando will serve as an illustration of the impact of Sports: It's More Than a Game. In October 2017, The Dr. Phillips Center for the Performing Arts will serve as the host location for the 2017 Worth Sports Summit. Orlando's sports industry - including homegrown technology and innovation, health & wellness, academics, architectural infrastructure and big events - serves as a case study for how a city can be shaped by its sports scene. Anticipated attendance is 100 targeted individuals. This is a unique opportunity to bring awareness to Downtown Orlando's dynamic economy to an audience we might not otherwise be able to engage.
