#### **Consent Agenda – Commissioner Comments**

**Commissioner Robert F. Stuart, District 3** – Commissioner Stuart stated he had some questions about Item C-4 (*Funding Agreement Between the City of Orlando and CanvsORL, Inc. for the establishment of the Canvs-Parramore Facility*) which have been answered by staff and thanked Economic Development Director Brooke Bonnett and Business Development Division Manager Lillian Scott-Payne for their work on this item, and further stated he had no concerns regarding the agenda.

*Development)) and Hearing/Ordinance 2<sup>nd</sup> Read No. 2017-28 (designating certain land generally located south of Rixey Street, west of Jamajo Boulevard, east of Lake Baldwin Lane and north of Hargrove Street and comprised of 0.96 acres of land, more or less, as Planned Development Zoning District with the Aircraft Noise Overlay District on the City's Official Zoning Maps (Economic Development) (Lake Baldwin 5 PD, ZON2017-00003)) and will abstain from voting on these two items and file proper paperwork with the Clerk.*

Mayor Dyer asked Commissioner Hill if she would be making a statement during the CRA meeting today and she replied she will in reference to Item CRA-1 (*Ranking and Contract Negotiations for Design-Build Services for CRA Parramore Residential Housing, RFP17-0247*) that was previously voted on at the June 5, 2017 City Council meeting.
