DESCRIPTION:

That part of Section 23, Township 24 South, Range 30 East, Orange County, Florida, described as follows:

Commence at the Southwest corner of Tract A, according to plat of LAKE NONA BOULEVARD FIRST ADDITION, as recorded in Plat Book 67, Pages 8 and 9, of the Public Records of Orange County, Florida; thence S66*42'01"W along the Northerly right—of—way line of an Orlando Utilities Commission Railroad right—of—way, as recorded in Official Records Book 3494, Page 2564, of the Public Records of Orange County, Florida, 722.05 feet to the East line of a 135.00 foot wide City of Orlando Power Line Easement, as recorded in Official Records Book 1838, Page 953, of said Public Records; thence N00°01'46"W along said East line, 693.75 feet to the POINT OF BEGINNING; thence continue N00°01'46"W along said East line, 20.00 feet; thence departing said East line run N89°58'14"E, 59.00 feet; thence S00°01'46"E, 110.04 feet; thence S87°32'05"E, 390.35 feet to the point of curvature of a curve concave Northwesterly having a radius of 51.50 feet and a chord bearing of N46°02'16"E; thence Northeasterly along the arc of said curve through a central angle of 92°51'17" for a distance of 83.47 feet to a non—tangent line; thence N87°57'59"E, 24.03 feet to a point on a non—tangent curve concave Westerly having a radius of 387.02 feet and a chord bearing of S03°53'49"W; thence Southerly along the arc of said curve through a central angle of 11°51'41" for a distance of 80.12 feet to a non—tangent line; thence N87°32'05"W, 486.72 feet; thence N00°01'46"W, 113.02 feet; thence S89°58'14"W, 35.00 feet to the POINT OF BEGINNING.

Being subject to any rights-of-way, restrictions and easements of record.
