




SKETCH OF DESCRIPTION

DESCRIPTION:

That part of Section 23, Township 24 South, Range 30 East, Orange County, Florida, described as follows:

Commence at the Southwest corner of Tract A, according to plat of LAKE NONA BOULEVARD FIRST ADDITION, as recorded in Plat Book 67, Pages 8 and 9, of the Public Records of Orange County, Florida; thence S66°42'01"W along the Northerly right-of-way line of an Orlando Utilities Commission Railroad right-of-way, as recorded in Official Records Book 3494, Page 2564, of the Public Records of Orange County, Florida, 722.05 feet to the East line of a 135.00 foot wide City of Orlando Power Line Easement, as recorded in Official Records Book 1838, Page 953, of said Public Records; thence N00°01'46"W along said East line, 713.75 feet to the POINT OF BEGINNING; thence continue N00°01'46"W along said East line, 28.00 feet; thence departing said East line run N89°58'14"E, 20.00 feet; thence S00°01'46"E, 28.00 feet; thence S89°58'14"W, 20.00 feet to the POINT OF BEGINNING.

Being subject to any rights-of-way, restrictions and easements of record.
