

**RESOLUTION SUPPORTING THE HONORARY
DESIGNATION OF A PORTION OF SILVER STAR ROAD
THROUGH THE CITY OF ORLANDO IN HONOR OF
LIEUTENANT DEBRA L. CLAYTON AND ESTABLISHING
AN EFFECTIVE DATE**

WHEREAS, Lt. Debra L. Clayton spent her formative years in Orlando, graduating from Dr. Phillips High School and the University of Central Florida; and

WHEREAS, Lt. Debra L. Clayton protected the residents of Orlando as a member of the Orlando Police Department for more than 17 years; and

WHEREAS, Lt. Debra L. Clayton impacted her community in many ways, including her work mentoring at-risk youth; and

WHEREAS, Lt. Debra L. Clayton epitomized the Orlando Police Department's motto: Courage. Pride. Commitment; and

WHEREAS, Lt. Debra L. Clayton lost her life in the line of duty on January 9, 2017;

NOW, THEREFORE, BE IT RESOLVED by the City Council for the City of Orlando, Florida in regular session duly assembled, that said Council hereby supports the State's effort to bestow an honorary designation to the portion of Silver Star Road within the jurisdictional limits of the City of Orlando from John Young Parkway to Pine Hills Road, designated as the "Lieutenant Debra Clayton Memorial Highway"; and

BE IT FURTHER RESOLVED the Florida Department of Transportation is hereby encouraged to erect suitable markers for the above-described designation; and

BE IT FURTHER RESOLVED that a copy of this Resolution shall be delivered to State Senator Randolph Bracy and State Representative Kamia Brown; and

BE IT FURTHER RESOLVED that this Resolution shall become effective upon adoption.
