1. DESCRIPTION: In 2006, the Orlando City Council approved an Agreement with the Community Foundation of Central Florida, Inc. (now known as the Central Florida Foundation) establishing the Legacy Trust for Orlando Children ("Legacy Trust"). The Legacy Trust is a donor-advised fund whose purpose is to make investments in programs and services that improve the lives of low-income children in the City of Orlando, starting in Parramore. At the October 24, 2016 Orlando City Council meeting, a disbursement of \$500,000 (#161024D01, of the \$575,0000 allocated in the FPR budget for this purpose) was approved for the Legacy Trust. The Families, Parks and Recreation Department is requesting approval for the remaining \$75,000, budgeted for this purpose in the Department's FY16-17 budget, be disbursed to the Central Florida Foundation, for deposit into the Legacy Trust for Orlando children, to continue its support of this important work.
