1. Call to Order

Eric Jackson, Chairman, called the meeting to order at 8:01 a.m.

2. Roll Call

Stephanie Herdocia, Board Administrator, performed roll call and determined a quorum was present.

3. Consideration of the Minutes

a. Approval of the Minutes from May 3, 2017

Richard Crabtree moved to accept the minutes of the May 3, 2017 meeting as presented and Mario Jimenez seconded the motion. The Board voted to approve the motion 7-0. Ayes: Crabtree, Coleman, Hopkins, Engel, E. Jackson, Jimenez, King.

5. Old Business

a. Telephone Policy, Eric Jackson, Chairman renewed the motion made at the May 3, 2017 Citizens' Police Review Board Meeting regarding adopting a telephone policy. Mr. Engel stated he was generally supportive of a telephone policy reserved for observation only. Mr. King stated he was previously in favor of a

Mr. Robert Jalca and Mrs. Christina Jalca of 3835 Martin Street, Orlando, Florida 32806, presented the Board Administrator with an Appearance Request Form. Stephanie Herdocia, Board Administrator, administered the oath to Mr. and Mrs. Jalca and invited them to begin. Mr. Rivers also announced the commencement of the Orlando Police Department's Social Media Campaign which would include traffic stop information.
