AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ORLANDO, FLORIDA, RELATING TO STREET POLE BANNERS; AMENDING SECTION 64.321, ORLANDO CITY CODE, CREATING THE MILK DISTRICT BANNER DISTRICT; PROVIDING FOR SEVERABILITY, CODIFICATION, CORRECTION OF SCRIVENER'S ERRORS, AND AN EFFECTIVE DATE.

WHEREAS, in 2009, the City of Orlando ("City") amended the City's sign code to allow for the placement of street pole banners in the City's Main Street districts and Downtown Development Board area; and

WHEREAS, the City desires to add the Milk District Main Street program as an area where street pole banners will be allowed, to be known as the Milk District Banner District, as shown on Figure A-7, attached to this ordinance; and

WHEREAS, at its regularly scheduled meeting of September 19, 2017, the Municipal Planning Board recommended to the City Council of the City of Orlando, Florida (the "Orlando City Council"), that the provisions of this ordinance are consistent with the applicable provisions of the City's adopted Growth Management Plan, are in the best interest of the public health, safety, and welfare, are in harmony with the purpose and intent of the Land Development Code of the City of Orlando, Florida (the "Land Development Code"), will not result in disorderly and illogical development patterns, and will not result in incompatible land uses; and

WHEREAS, the Orlando City Council hereby finds and determines that this ordinance is consistent with the applicable provisions of the City's adopted Growth Management Plan, is in the best interest of the public health, safety, and welfare, is in harmony with the purpose and intent of the City's Land Development Code, will not result in disorderly and illogical development patterns, and will not result in incompatible land uses.
