

That part of Rosalind Avenue (platted Speir Ave), SPEIR'S ADDITION TO THE CITY OF ORLANDO, according to the plat thereof as recorded in Plat Book B, Page 124 of the Public Records of Orange County, Florida and that part of Lots 14 and 15 HILLMAN'S 2ND ADDITION TO ORLANDO, according to the plat thereof as recorded in Plat Book D, Page 85 of the Public Records of Orange County, Florida being more particularly described as follows:

COMMENCE at the Northeast corner of Lot 9 of said SPEIR'S ADDITION, said point being a point on the West right of way line of N Rosalind Avenue, a 63 foot wide public right of way; thence South 00 degrees 36 minutes 23 seconds East 5.00 feet along said West right of way line to the POINT OF BEGINNING; thence departing said West right of way line North 89 degrees 44 minutes 30 seconds East 60.00 feet to a point on the West boundary of said Lot 14; thence North 00 degrees 36 minutes 23 seconds West 5.00 feet along said West boundary to the Northwest corner of said Lot 14; thence departing said West boundary North 89 degrees 44 minutes 30 seconds East 47.33 feet to a point on the East boundary of the West 47.33 of said Lot 14; thence South 00 degrees 36 minutes 23 seconds East 5.00 feet along said East boundary to a point on the South right of way line of said E Livingston Street; thence South 89 degrees 44 minutes 30 seconds West along said South right of way line 44.33 feet to a point on the East right of way line of said N Rosalind Avenue; thence South 00 degrees 36 minutes 23 seconds East 271.00 feet to a point on the North right of way line of E Ridgewood Street, a 60 foot wide public right of way, according to Plat Book D, Page 85 of the Public Records of Orange County, Florida; thence South 89 degrees 44 minutes 43 seconds West 45.61 feet along said North right of way line to a point on the West right of way line of N Rosalind Avenue, a variable width public right of way per Official Records Book 4146, Page 1773 of the Public Records of Orange County, Florida said point being the beginning of a non-tangent curve concave Southwesterly and having a radius of 430.00; thence from a tangent bearing of North 26 degrees 19 minutes 48 seconds West run Northwesterly along the arc of said curve and said West right of way line 36.83 feet through a central angle of 04 degrees 54 minutes 27 seconds to the end of said curve, being a point on the West right of way line N Rosalind Avenue, a 63 foot public right of way; thence departing said North right of way line North 00 degrees 36 minutes 23 seconds West 238.64 feet along said West right of way line to the Point of Beginning.
