AGREEMENT

This Agreement, made the date both parties have executed it, is between The School Board of Orange County, Florida on behalf of Orange County Public Schools (hereinafter "OCPS"), a political subdivision of the State of Florida, with its principal offices at 445 West Amelia Street, Orlando, Orange County, Florida, 32801, and the City of Orlando (hereinafter "the User"), a nonprofit corporation (federal employer ID number 59-6000396) incorporated under the laws of the State of Florida, or a nonprofit civic association, or a governmental agency, with its principal offices at 400 S. Orange Ave, 4th Floor, Orlando, FL 32802, from July 1, 2018, through June 30, 2019.

1. OCPS hereby licenses and authorizes the User to use the following school bus(es) owned by OCPS solely for the purpose of transporting school-age children (and a sufficient number of adult volunteers or employees of the User to maintain order and decorum on each bus):

The bus(es) shall only be used to transport to and from the following activity sponsored by the User: various events at various locations during various date(s) and times. (*Specific instructions [ET105] regarding the beginning point and ending point of each leg of the trip shall be attached and shall be part of this Agreement.*) OCPS reserves the right to substitute comparable buses.

- 2. The bus(es) shall only be operated by OCPS employee(s) ("Bus Drivers") assigned by the OCPS's Transportation Department for that purpose. Bus Drivers have passed background check, participate in random drug testing, and have a valid commercial driver's license.
- 3. School buses will be available for field trips on school days between 9:45 a.m. and 1:00 p.m. except on Wednesdays when they will be available between 9:45 a.m. and 12:00 p.m. Please share with all staff members involved with field trips that all buses must be back and unloaded at the originating school no later than 1:00 p.m. on regular school days (12:00 p.m. on Wednesdays). Buses are also available Monday through Friday after 4:45 p.m. (3:45 p.m. on Wednesdays) and all day on weekends and student holidays.
- 4. The User shall pay OCPS for the use of the bus(es) and the Bus Driver(s), the following base fee: \$41.00 per hour, per bus, \$0.40 per mile, calculated as specified below. The minimum charge is \$82.00 for each bus, covering the first two (2) hours of bus use. If the trip is built into a route, no additional field trip time will be incurred and only actual route time and mileage will be billed.

Bus use time is calculated from the time the bus leaves the OCPS bus depot to pick up the User's passengers until the bus has returned to the OCPS bus depot after dropping off the User's passengers at the conclusion of the trip. Bus Drivers are not available for overnight trips. The bus use time shall include the time of duration of the trip with a drop-off at the final destination and the time of the Bus Driver to return to the bus depot. Bus Drivers will be available to return to the site to pick up passengers. The return bus time shall include the time of duration of the trip with a drop-off at the final return destination and the time of the Bus Driver to return to the OCPS bus depot.

Bus mileage includes all mileage from the OCPS bus depot until the bus returns to the OCPS bus depot. OCPS prices per mile shall include fuel charges and include applicable fuel taxes (subject to change). Should there be a significant increase in fuel prices, OCPS reserves the right to notify the contracted service of any price escalations that may apply. OCPS will provide thirty (30) days notification and will only charge the actual increase in fuel price as incurred by OCPS.

- 5. The User shall pay all parking fees. OCPS shall be responsible for fuel and routine maintenance of the bus(es).
- 6. All trip requests must be submitted ten (10) business days in advance of requested service on form ET105 (a copy of which can be found below). Service cannot be guaranteed and a \$10.00 per hour late fee may be applied for requests that are received with less than ten (10) days' notice. A two (2) hour minimum charge will be accessed for any cancellation received less than two (2) business days before the scheduled trip.
- 7. Unless prohibited by law, the User agrees to and shall indemnify, defend, and hold OCPS, the School Board, its officers, agents, and employees, harmless from and against any and all actions, claims, judgments, or liability arising from or in connection with, or by virtue of, the User's use of the bus(es).
- 8. The User shall, at all times during the use of the bus(es), maintain in full force and effect a policy or policies of insurance with a company or companies acceptable to OCPS designating the Board ("The School Board of Orange County, Florida") as a named insured, covering all claims and judgements of whatsoever nature or kind arising from or by virtue of the User's use of the bus(es) and other obligations under this Agreement with policy limits which meet or exceed the following:

\$300,000 for any one person for bodily injury or death, \$1,000,000.00 for any one accident for bodily injury or death. In addition, each required insurance policy must provide for at least five (5) days advance written notice to OCPS before any cancellation or reduction in the insurance coverage.

If the User is a political subdivision of the State of Florida, the User is only obligated to indemnify the Board to the extent allowable by law and the User is not obligated to provide insurance.

The User shall immediately submit to the OCPS Transportation Department's Field Trip Office a certificate of insurance showing liability coverage naming the Board as an insured party. The User shall keep such insurance in full force and effect to protect the Board and each Bus Driver against any claim or judgment which may arise from or by virtue of the use of the bus(es). [NOTE: A certificate of insurance shall not modify or waive the User's obligations under Paragraphs 6 and 7.]

- 9. In no event shall OCPS be responsible for any incidental or consequential damages suffered by the User or by any other person arising from or in connection with OCPS's performance under, or its failure to fully or properly perform, this Agreement. OCPS's liability for any compensatory damages suffered by the User shall be limited to an amount equivalent to the minimum charge specified in Paragraph 4.
- 10. OCPS reserves the right to cancel this Agreement, or any of the scheduled trips, without penalty, upon ten (10) business days' notice to the User.

The User may cancel this Agreement, without cost or obligation, if such notice is given in such a manner that it is received by the OCPS Transportation Department's Field Trip Office at least two (2) business days in advance of the scheduled commencement of the trip. Otherwise, if the User cancels this Agreement, it shall pay OCPS the minimum charge specified in Paragraph 4.

- 11. The User shall be responsible for the supervision of all passengers on the bus(es) and shall maintain proper order, decorum, and discipline on the bus(es) at all time. If the activities on any bus are a threat to its safe operation, the Bus Driver may refuse to operate the bus and may take such other actions as are appropriate. Without limiting its other obligations under this Agreement, the User acknowledges and agrees that it shall pay OCPS for all damage to the bus(es) caused by the negligence or misconduct of the User or any of its passengers.
 - 12. Under no circumstances shall any bus leave the State of Florida.

- 13. Any judicial proceeding for the enforcement of this Agreement or in connection with its breach shall be instituted and maintained only in the State court of appropriate jurisdiction in Orange County, Florida.
- 14. This Agreement constitutes the entire understanding and agreement of the parties with respect to the use of the bus(es).
- 15. The person(s) executing this Agreement warrant and represent that they have lawful authority to bind the party on whose behalf they execute the Agreement.
