# **1222.1** SUBJECT: USE AGREEMENTS, LEASES, AND CONCESSION AGREEMENT

:1 OBJECTIVE:

Provide representation of the City of Orlando in negotiating certain use agreements, leases, and concession agreements for the <u>facilities\_Venues</u> under the management of <u>the</u>Orlando <u>Centroplex\_Venues</u>.

#### :2 AUTHORITY:

This procedure amended by City Council April 19, 1993

#### :3 DIRECTION:

<u>ExecutiveChief Venues Officer (CVO)</u>-Director or Designee, as an appointed official, serves at the pleasure of, and receives direction from the Mayor-or the Mayor's-Designee.

#### :4 METHOD OF OPERATION:

#### A. General

- The <u>ExecutiveCVO Director or dDesignee</u> shall represent the City in negotiating <u>certain all</u> use agreements, leases, <u>novelty</u> and concession agreements with users, tenants, concessionaires, and prospective users at the <u>Orlando ArenaAmway Center</u>, <u>Orlando Citrus BowlCamping World</u> <u>Stadium</u>, <u>and</u> Tinker Field, <u>Mennello Museum of American Arts</u>, and <u>Harry</u> <u>P. Leu Gardens Expo Centre</u>, <u>McCracken Field</u>, <u>Mayor Bob Carr Performing</u> <u>Arts Centre</u>, and Ben White Raceway, hereinafter referred to as those facilities comprising the Orlando <u>Centroplex Venues</u>
- 2. The <u>CVOExecutive</u> <u>Director or dDesignee</u> shall execute <u>oin</u> behalf of the City, facility use agreements <u>in accordance with City Policy & Procedure 161.3</u> and on standard forms approved by the Office of Legal Affairs, and for rates approved by City Council for use of the facilities comprising the Orlando <u>CentroplexVenues</u>. If there is any deviation from the approved standard form, same will be referred to the Office of Legal Affairs for approval prior to execution by the Director. Rates shall be in accordance with standard schedules approved by City Council. When it is deemed to be in the overall best interest of the City, deviations from the rate schedule of 15% (fifteen percent) or less of the amount due the City of Orlando under the terms of the original contractmay be authorized by the <u>Executive</u> Director; deviations in excess of 15% may be approved by the <u>Chief Administrative</u> Officer<u>CVO</u>. Deviations from the rate schedules may only be made by written amendment to the agreement and will be-subject to annual auditing. <u>The CVO may establish internal operating policies and procedures to facilitate the operation of the venues facilities.</u>
- Leases, <u>novelty</u>, concessions, and other agreements related to the facilities comprising the Orlando <u>Centroplex-Venues</u> shall be executed by the <u>Executive</u> <u>DirectoCVOr or designee</u> in accordance with applicable provisions of the City Code and City Policies and Procedures. All such leases, <u>concessions</u>, and <u>other</u> agreements with durations in excess of <u>one-three</u> years must be approved by

City Council.
