

ORDINANCE NO. 2018-40

1 **AN ORDINANCE OF THE CITY COUNCIL OF THE**
2 **CITY OF ORLANDO, FLORIDA, AMENDING**
3 **ORDINANCE NO. 2017-67 RELATING TO**
4 **CERTIFICATES OF USE; PROVIDING A NEW**
5 **IMPLEMENTATION DATE; PROVIDING FOR NON-**
6 **CODIFICATION, CORRECTION OF SCRIVENER'S**
7 **ERRORS, SEVERABILITY, AND AN EFFECTIVE**
8 **DATE.**

10 **WHEREAS**, on January 8, 2018, the City Council of the City of Orlando,
11 Florida enacted Ordinance No. 2017-67, establishing a certificate of use process;
12 and

14 **WHEREAS**, the City is currently reviewing and establishing a process for
15 issuing certificates of use, which will take more time than anticipated; and
16

17 **WHEREAS**, the Orlando City Council hereby finds and declares that this
18 ordinance is in the best interest of the public health, safety, and welfare.

20 **NOW THEREFORE, BE IT ENACTED BY THE CITY COUNCIL OF THE**
21 **CITY OF ORLANDO, FLORIDA, AS FOLLOWS:**

23 **SECTION 1. NEW IMPLEMENTATION DATE.** Section 3 of Ordinance No.
24 2017-67 is hereby amended to change the implementation date from October 1,
25 2018 to October 1, 2019.

27 **SECTION 2. NON-CODIFICATION.** The provisions of this Ordinance shall
28 not be included or incorporated within the Code of the City of Orlando, Florida.

30 **SECTION 3. SCRIVENER'S ERROR.** The city attorney may correct
31 scrivener's errors found in this ordinance by filing a corrected copy of this
32 ordinance with the city clerk.

34 **SECTION 4. SEVERABILITY.** If any provision of this ordinance or its
35 application to any person or circumstance is held invalid, the invalidity does not
36 affect other provisions or applications of this ordinance which can be given effect
37 without the invalid provision or application, and to this end the provisions of this
38 ordinance are severable.

40 **SECTION 5. EFFECTIVE DATE.** This ordinance takes effect upon
41 adoption.
