**RELEASE OF EASEMENT**

That pursuant to due and lawful authority, and pursuant to the directions of the City Council of the said City of Orlando, and the directions of the Orlando Utilities Commission, the said parties of the first part for and in consideration of the sum of One Dollar (\$1.00) and other valuable considerations in hand paid by the party of the second part, the receipt whereof is hereby acknowledged, have remised, released and quitclaimed, and by these presents do hereby remise, release and quitclaim unto the said party of the second part, their successors and assigns, forever, all of their right, title, and interest in and to the right-of-ways and easements over and under the land hereinafter described, which was granted by THE SCHOOL BOARD OR ORANGE COUNTY, FLORIDA, unto the parties of the first part herein by an easement dated the 22nd day of May, 1979, recorded in Official Records Book 3017, Page 977, of the Public Records of Orange County, Florida, on, over, through, across and under the land situate in the County of Orange and State of Florida,

described as follows, to-wit:

TOGETHER with all rights, including, without limitation, all rights of ingress and egress to, over and under the said land, granted to the parties of the first part herein, in and by the aforesaid instruments dated the 22nd day of May, 1979.

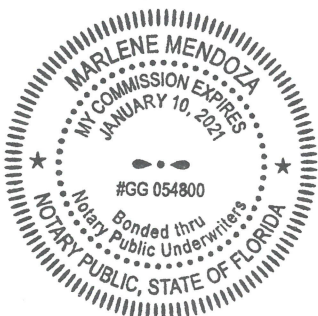
