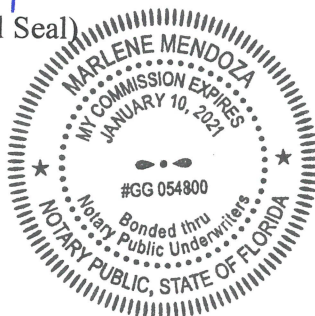

From the Northwest corner of the Southeast 1/4 of Section 10, Township 23 South, Range 30 East, run S 89°53'46" E, along the North line of said Southeast 1/4, 995.11 feet, thence S 00°06'23" W, 288.86 feet to the Point of Beginning; thence run N 89°57'19" E, 670.19 feet to a point on the Westerly Right Of Way line of Woodgate Blvd., thence S 00°09'16" W, along said Westerly Right of Way line, 975.55 feet to a point on the New Northerly right of Way line of Pershing Avenue (90 foot right of way), thence S 89°57'19" W along said Northerly Right of Way line 669.37 feet, thence N 00°06'23" E, 975.55 feet to the point of beginning.
