A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ORLANDO, FLORIDA, RELATING TO THE FLORIDA **HOUSING FINANCE CORPORATION'S RFA 2018-112** UNDER THE LOW INCOME HOUSING TAX CREDIT PROGRAM; ADOPTING A PLAN FOR A PROCESS AND STANDARDS OF REVIEW FOR AWARD OF THE LOCAL **GOVERNMENT PREFERENCE UNDER RFA 2018-112;** PROVIDING FOR SEVERABILITY, CORRECTION OF SCRIVENER'S ERRORS, REPEAL OF CONFLICTING RESOLUTIONS, AND AN EFFECTIVE DATE.

WHEREAS, the Florida Housing Finance Corporation (the "FHFC") has recently, or will soon, issue Request for Application #2018-112 (RFA 2018-112) under the Low Income Housing Tax Credit program; and

WHEREAS, the FHFC's competitive review process under RFA2018-112 will likely give preference to applicants that have secured a financial contribution to their project from the applicable local government (known as the "Local Government Preference"); and

WHEREAS, the purpose of this resolution is to adopt a review process and standards of review for the City of Orlando's possible award of a Local Government Preference under RFA 2018-112; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ORLANDO, FLORIDA, AS FOLLOWS:

SECTION 1. PLAN ADOPTED. The Plan for a Process and Standards of Review for Award of the Local Government Preference Under RFA 2018-112, attached to this resolution as Exhibit A, is hereby adopted. The plan shall be implemented by the director of Housing and Community Development.

SECTION 2. SEVERABILITY. If any provision of this resolution or its application to any person or circumstance is held invalid, the invalidity does not affect other provisions or applications of this resolution which can be given effect without the invalid provision or application, and to this end the provisions of this resolution are severable.

SECTION 3. SCRIVENER'S ERROR. The City Attorney may correct scrivener's errors found in this resolution by filing a corrected copy of this resolution with the City Clerk.

SECTION 4. REPEAL. All resolutions or parts of resolutions previously adopted and in conflict with this resolution are hereby repealed.

SECTION 5. EFFECTIVE DATE. This resolution takes effect immediately upon adoption.
