Grantee agrees and consents to the conditions of the proposal submitted to the Energy Foundation and to the following conditions of the grant:

Grantee shall use this grant solely for the purposes as expressed in City of Orlando's proposal document submitted to the Energy Foundation which incorporates a description of the project work to be provided, dated September 10, 2018, and project budget, dated September 10, 2018 to the Energy Foundation. It is understood that these grant funds will be used for such purposes substantially in accordance with the budget submitted. Grantee shall repay to the Energy Foundation any portion of the amount granted which is not used for the purposes of this grant.

The grantee agrees that no funds provided pursuant to this Grant Agreement may be used to contact, or urge the public to contact, members of a legislative body for the purpose of proposing, supporting, or opposing legislation; or to advocate the adoption or rejection of legislation. See Treasury Regulation section 1.501(c)(3)-1(c)(3)(ii).

Grantee ensures that the grant funds under this award will be used in compliance with all applicable anti-terrorist financing and asset control laws, regulations, rules and executive orders. Grantee also agrees to take all reasonable precautions to ensure that any person or group expected to receive money from the grantee will neither make any payment nor provide any material support to any person on any United States government list of suspected terrorists.

Grant payment will be generated upon the Energy Foundation's receipt of the signed grant agreement.

A final financial report is due according to the schedule below. As standard practice, Energy Foundation does not require narrative reports for grants to government entities; however, the Foundation reserves the right to request narrative reporting in special circumstances where we believe the additional detail will help us better understand your work. Grantee shall notify the Energy Foundation of any organizational changes during the term of the grant, including: but not limited to, changes in key personnel, changes in tax status, and changes in the project timing or goals.

Grantee shall permit representatives of the Energy Foundation to visit the premises during normal business hours and review the activities of the Grantee with respect to the programs supported by this grant.

Grantee may announce receipt of this grant. Please furnish the Energy Foundation with any results of this announcement.
