# MINUTES

### 1. Welcome:

The meeting was called to order at 2:07 p.m.

#### 2. Roll Call:

Ashley Edwards, Recording Secretary, announced that a quorum was present, with all members in attendance.

#### 3. Committee Training:

- a. Candace Cardillo, Board Coordinator, reviewed the attendance policy with committee members.

### 6. Project Manager Report:

Mary-Stewart Droege, Project Manager, gave a two-part presentation. The first part of the presentation focused on the background and criteria of the I-4 Ultimate Art Project as well as

a review of the proposed art site. The larger property is generally located south of W. Colonial Dr., north of Concord St., east of N. Garland Ave. and I-4, and west of CSX railroad tracks. The second part of the presentation reviewed the multi-page Call for Artists, which is to be issued through the CaFÉ on-line art solicitation website.

A committee discussion then ensued and committee members made the following recommendations for the Call for Artists, including:

- Artists should provide two references;
- A minimum artist stipend amount should be identified in the solicitation;
- Project approach should have a limited scope as it concerns initial artist submittals;
- A project timeline extension should be requested from SGL and its I-4 Ultimate Art Endowment partners to better support the multi-step art solicitation process and address the unexpected delays due to COVID-19.

### 7. Next Steps:

Mary-Stewart Droege, Project Manager, presented the next steps to include finalizing the Call for Artists and establishing a timeline.

The next meeting of the I-4 Ultimate Art Committee is TBD.
