The applicant's capital investment for the proposed improvements is estimated at \$40,770 based upon three contractor estimates provided for the above referenced improvements, thus the applicant is eligible for funding assistance of up to \$15,000. The DCRBIP Grant Review Committee convened on March 4, 2020 and recommended approval for funding assistance of up to \$15,000 toward the improvements for window repair and hardscape improvements and subject to review and approval of the City Attorney's Office and authorization for the Chairman of the CRA and Executive Director to execute such Funding Agreement.
