Good Afternoon Janeiro,

The firm recommended by the selection committee does not meet the goals of the City's MWBE requirement. However, awarding the contract to the second-ranked firm with some MWBE participation is not a viable option. The second-ranked firm's cost proposal is more than three times the committee recommended firm, or roughly \$940,000 more. The price difference is greater than that allowed by the Financial Reasonableness Policy to facilitate MWBE participation. More importantly, this contract is vital for STW. Without it, we will not be able to maintain the ROW's in the next several weeks. This urgency also means the division cannot withstand a time delay associated with a decision to re-advertise and solicit new proposals. For these reasons, I am requesting you waive the City's MWBE requirements on this RFP and concur with Procurement and Contracts' recommendation to award the contract to Ameriscape, Inc.
