# Awards/Presentations/Recognitions

Proclaiming October 28 - November 3, 2017 as "Mobility Week"

Mayor Dyer called on Transportation Department Director Billy Hattaway who introduced Florida Department of Transportation (FDOT) Rail and Transit Supervisor Libertad Acosta-Anderson and Kimley-Horn and Associates, Inc. Marketing and Public Relations Director Poorna Bhattacharya. Ms. Acosta-Anderson stated that Mobility Week is a cooperative effort between FDOT and partner agencies to promote multi-modal transportation and gave a brief presentation, a copy of which is included as supplemental papers to these minutes. Ms. Acosta-Anderson spoke about the schedule of events during Mobility Week 2017 and the FDOT's Mix-It-Up Challenge. More Mobility Week 2017 information can be found on the FDOT website. Mayor Dyer read the proclamation.

# Proclaiming October 29, 2017 as "Stroke Awareness Day"

Mayor Dyer called on Chief Service Officer Marcia Hope Goodwin who introduced Deanna Coopersmith-Marquez, President of The Scott Coopersmith Stroke Awareness Foundation which was founded after her husband, Scott Coopersmith, died of a stroke at the age of 32. Ms. Coopersmith-Marquez thanked Mayor Dyer and City Council for recognizing the importance of stroke awareness and stated there are approximately 7,000,000 stroke survivors in the country and stroke is the fifth leading cause of death, yet most people are not familiar with the signs and symptoms of stroke. The Scott Coopersmith Stroke Awareness Foundation exists to raise awareness and raise funds to help stroke survivors. Mayor Dyer read the proclamation.

### Mayor's Update

# Commissioner Patty Sheehan "Champion of Equality" Award

Mayor Dyer announced that Commissioner Patty Sheehan was recognized with Harbor House of Central Florida's "Champion of Equality" award at last week's annual Purple Door Luncheon. Mayor Dyer and the City Council thanked Commissioner Sheehan for her work toward ending domestic violence and congratulated her on receiving the award, given in October during Domestic Violence Awareness Month.

## Hurricane Irma and Hurricane Maria Updates

Mayor Dyer noted it has been several weeks since Hurricane Irma made landfall in Orlando and crews and contractors have removed more than 60% of the debris caused by the storm. The City has completed its first pass of debris collection in every residential area and is moving into the second out of three phases of collection. Mayor Dyer reminded everyone to continue to bag loose debris and bring it to the curb. Residents can get updated debris collection information on the City's website. Mayor Dyer also noted that the City continues to help Puerto Rican and U.S. Virgin Island families displaced by Hurricane Maria through a temporary Hispanic Office for Local Assistance (HOLA) at the Disaster Relief Center in the Orlando International Airport. The HOLA office in the Disaster Relief Center continues to connect evacuees with more than one hundred government and community organizations to help find jobs, housing, healthcare services and other resources. Since its inception, the HOLA Office at the Disaster Relief Center has assisted over 2,300 individuals and 822 families. The Disaster Relief Center will continue operating from 9:00 A.M. to 7:00 P.M. seven days a week, until Monday, November 6, 2017. # **Agenda Items of Note**

#### Item A-2 - Orlando's Poet Laureate

Mayor Dyer announced that this item will approve the appointment of Orlando's first Poet Laureate. The search began for Orlando's official storyteller in July of this year for a poet laureate to promote an appreciation of poetry among residents and inspire new generations of literary artists and readers of literature. Mayor Dyer recognized members from the United Arts of Central Florida and Burrow Press and thanked them for their partnership with the City in developing the qualifications for the position and then assisting during the search process. Mayor Dyer also thanked the City's Poet Laureate Selection Committee for their review of 49 applications. Mayor Dyer then introduced Susan Lilley, a teacher and published poet, as Orlando's first Poet Laureate. Ms. Lilley is a University of Central Florida graduate whose love of literature stems from early in her education in Orlando's public schools. Mayor Dyer thanked and congratulated Ms. Lilley for her commitment to telling Orlando's story and promoting the literary arts in the community and announced that she will share her first official poem later in today's meeting.

# Item C-9 - Renewal of Orlando Main Streets District Agreements for FY 2017-2018

Mayor Dyer stated that this item will renew the City's nine agreements with its Main Streets. The Main Streets program has brought nearly 6,000 new full and part time jobs, 975 businesses and more than \$1 billion in investment to the community. This year, the City is changing its funding model to give an opportunity for Main Street Districts to acquire an additional \$25,000 more than in years past. Districts that have been in the Main Streets program for five or more years would receive \$25,000 and the City will match funds raised by the District up to \$50,000. Mayor Dyer recognized the Main Street managers, board members and staff and thanked them for their contributions to the City.

Item C-11 – Johnson & Johnson Consumer Inc. Qualified Target Industry Tax Refund Resolution Mayor Dyer stated that this resolution will support the creation of thirty new, high quality jobs at the Johnson and Johnson Human Performance Institute in Lake Nona. Johnson and Johnson is looking to expand its footprint of leadership development and training center operations and is considering Orlando for the expansion project. Mayor Dyer thanked Johnson and Johnson Senior Director of State Government Affairs Kevin Buckley for attending today's meeting.

At approximately 3:02 P.M. the official business of the City was concluded and Commissioner Samuel B. Ings left the meeting.

#### 19. General Appearances

Cheryl Difienz, appearing on her own behalf, spoke about her involvement in the community and volunteer activities.

Rasha Mubarak, appearing on her own behalf, stated she is the Central Florida Regional Director of the Council of Islamic-American Relations of Florida and part of the TRUST Orlando Coalition, and is requesting an open debate about creating an ordinance, stating she believes there is no transparency with a resolution and that a resolution is not a solution.

Oscar Arriaza, speaking as a member of Fuerza Inmigrante and El Acta de Confianza of Orlando, stated a resolution is not a solution.

Hugo Chable-Lara, appearing on his own behalf, stated he is not in support of a resolution.

Mayor Dyer commented that some governments have a Trust Act in different forms. This group (TRUST Orlando Coalition) approached the City about fashioning something that will work for them and for the City as to whether the Orlando Police Department will detain people on the basis of immigration status. Mayor Dyer stated that the City is not the appropriate government to petition since the City does not run the jail, but since Orlando is viewed as progressive this group approached the City to create an ordinance versus a resolution. Mayor Dyer explained that an ordinance governs the activities of people or businesses outside of the City and that a policy governs the actions of City people and businesses, i.e. police policies, hiring policies, etc.

Commissioner Tony Ortiz spoke about the difference between an ordinance and a resolution; ordinances are for the public, policy affects employees.

Mayor Dyer spoke about passing an ordinance regulating the flying of drones and passing a resolution granting same sex benefits for City employees and why each was important for its purpose.

At approximately 3:18 P.M. Commissioner Tony Ortiz left the meeting and did not return.

Ryan Marini, appearing on her own behalf, stated she works for Mi Familia Vota, is asking for an ordinance and that a resolution is not a solution.

Bernarda Garcia, appearing on her own behalf, stated she is in support of an ordinance.

Maria Rivera, speaking as a member of Fuerza Inmigrante and El Acta de Confianza of Orlando, stated a resolution is not a solution.

Stephanie Wheeler, appearing on her own behalf, stated she is a University of Central Florida faculty member and representative of the United Faculty of Florida, and that a resolution is not a solution.

Claudia Schippert, appearing on her own behalf, stated she works at University of Central Florida, is a representative of the Interfaith Council of Central Florida and that a resolution is not a solution.

Diego Cadena, appearing on his own behalf, stated that a resolution is not a solution.

Esteban Garces filed a General Appearance Request but did not appear when his name was called by Mayor Dyer.

Ronald Greene, appearing on behalf of Unite Here, stated that a resolution is not a solution.

Bejum Beceril, appearing on her own behalf, stated she works with Council on American-Islamic Relations (CAIR) Orlando and that a resolution is not a solution.

Yesica Ramirez, appearing on behalf of Farm Workers Association of Florida, stated that a resolution is not a solution.

Geovany Lopez, appearing on his own behalf, stated he is a member of the Farm Workers Association of Florida, and that a resolution is not a solution.

Derek Davie, appearing on his own behalf, stated that a resolution is not a solution.

Ivan Vasquez, appearing on behalf of Farm Workers Association of Florida, stated that a resolution is not a solution.

Isabel Vinent, appearing as Deputy Director of the Florida Immigrant Coalition, stated that a resolution is not a solution.

Mayor Dyer commented that he understands the motivation and purpose of the Trust Act and is trying to fashion something beneficial. All of the City's policies already implement the concerns. Orlando Police do not arrest, detain or inquire about immigration status within the confines of the City and does not run the jail to which the United States Immigration and Customs Enforcement (ICE) could order detention. Mayor Dyer stated that he understands Orlando sets the tone for other entities and the City's policies are how employees are directed to behave so an ordinance is not appropriate in this situation. A resolution can reiterate the City's policies which is why the City is seeking a resolution; to restate the City's policies. Mayor Dyer stated that an ordinance can be changed through two readings and a City Council vote so a resolution has staying power as strong as an ordinance. The City will continue to work with organizations and the City's legal department to demonstrate Orlando's willingness to step forward on this issue. Discussion was had by Commissioner Patty Sheehan and Commissioner Robert F. Stuart on this matter and Mayor Dyer thanked everyone who commented at today's meeting on this issue.
