Minutes

Commissioner Patty Sheehan moved and Commissioner Regina I. Hill seconded a motion to waive the reading of the December 11, 2017 Workshop, Agenda Review and City Council meeting minutes and accept the minutes as written, and vote carried unanimously with minutes approved as written.

Awards/Presentations/Recognitions

Proclaiming January 7 – 15, 2018 as “Dr. Martin Luther King Jr. Holiday Week”

Mayor Dyer called on Chief Service Officer and Director of Community Affairs and Human Relations Marcia Hope Goodwin, who introduced Mayor Dyer’s 2018 Martin Luther King Commission members. Mayor Dyer’s 2018 Martin Luther King Commission Chairperson Brandy Hand recognized and thanked Marcia Hope Goodwin and Director of Urban Development Walter Hawkins for their 25 years of support and commitment to serving the community and the Orlando Mayor’s Martin Luther King Commission. Chairperson Hand also thanked City staff and Commission sponsors for their support. Mayor Dyer read the proclamation.

Proclaiming January 8, 2018 as “City of Croix-des-Bouquets Day in the City of Orlando”

Mayor Dyer called on Commissioner Samuel B. Ings to present the proclamation. Commissioner Ings announced that Consul General Pierre Max Charles of the Consulate of the Republic of Haiti in Orlando would be accepting the proclamation on behalf of Croix-des-Bouquets Mayor Rony Colin, who could not attend today’s meeting. Commissioner Ings read the proclamation.

Mayor’s Update

Remembering Lt. Debra Clayton

Mayor Dyer noted that tomorrow marks one year since the passing of Orlando Police Department Lt. Debra Clayton. Mayor Dyer invited everyone to honor Lt. Clayton and her legacy of impacting Orlando’s residents by joining him and Orlando Police Department Chief John Mina in a half-mile community walk beginning at 4:00 P.M. at the Dr. I. Sylvester Hankins Neighborhood Center. Mayor Dyer stated that Orlando will never forget Lt. Clayton, as well as Orange County Sheriff’s Office Deputy First Class Norman Lewis, who also lost his life one year ago tomorrow.

Orlando Police Department’s Puerto Rico Hurricane Maria Relief Effort Deployment

Since Hurricane Maria devastated Puerto Rico in September of last year, City staff and communities have been working to assist evacuees and those remaining on the island. As part of the Puerto Rico Federal Emergency Management Agency’s request for law enforcement assistance, twelve members of the Orlando Police Department (OPD) were deployed to Puerto Rico for almost two weeks. Mayor Dyer called on OPD Deputy Chief Orlando Rolon to provide an update. Deputy Chief Rolon introduced each officer who deployed to Puerto Rico and gave a photo presentation to City Council of the work done while there, which is included as supplemental papers to these minutes. Mayor Dyer thanked the officers and the City’s Police Department for their outstanding work in this relief effort.

University of Central Florida Knights Football Celebration

Mayor Dyer shared the good news that on January 1, 2018 Orlando’s “Hometown Team” became Orlando’s “Perfect Hometown Team.” The University of Central Florida Knights defeated the University of Auburn Tigers in the Peach Bowl to finish the year as the undefeated national champions. Mayor Dyer invited everyone to join him tonight in Downtown Orlando to celebrate the UCF Knights at the Church Street Block Party at 6:00 P.M. The event includes a pep rally and national championship recognition.

Parramore Farmer’s Market Opening

Mayor Dyer announced that the opening of the Parramore Farmer’s Market on Saturday, January 6, 2018 was a success. In particular, over \$2,000 of Black Bee Honey was sold in one day by participants in the Parramore Kidz Zone!
