Mayor Dyer called on Human Resources Director Ana Palenzuela to introduce the presentation of the 2017 Dennis McNamara Employee of the Year Awards. Ms. Palenzuela introduced Maryann McNamara Villarroel and thanked the McNamara family for over 30 years of sponsorship of the award. Ms. Palenzuela called on Deputy Director of Public Works Jim Hunt to introduce the award winners from the Public Works Department. Mr. Hunt presented 2017 Dennis McNamara Employee of the Year Awards to City Surveyor Richard Allen and Public Outreach Coordinator Daniel Friedline and thanked them for their outstanding service to the City of Orlando. Orlando Police Chief John Mina introduced Orlando Police Officer John Earle and presented him with the 2017 Dennis McNamara Employee of the Year Award and noted his outstanding service to the City of Orlando. Director of Families, Parks and Recreation Lisa Early introduced Regional Center Manager Alexandra Temes and presented her with the 2017 Dennis McNamara Employee of the Year Award and noted her outstanding service to the City of Orlando. A photograph was taken of each winner with City Council earlier in the day. Each winner received \$750 and an award jacket.

At approximately 2:26 P.M. Mayor Dyer recognized Valencia College students in attendance at today's meeting and expressed his appreciation for their participation.

Mayor's Update

Moment of Silence for Marjorie Stoneman Douglas High School and City of Parkland Communities

Mayor Dyer expressed the City's heartfelt sorrow to the Marjorie Stoneman Douglas High School community and the City of Parkland in the wake of the recent tragedy at the high school. Mayor Dyer stated that City Attorney Mayanne Downs traveled to Parkland to assist the school board with legal issues, including Orlando's experience in setting up an assistance fund and navigating public records requests. Mayor Dyer asked for a moment of silence for the community.

Hearings/Emergency Ordinances #1 - Ordinance No. 2018-16 relating to Disorderly Conduct; amending Chapter 43, Section 43.065 of the Code of the City of Orlando, Florida

Mayor Dyer stated that any person who makes a threat on social media and that threat turns out to be a false threat or hoax, can be arrested for that offense. However, if the same threat is made with intent but without directly specifying a person and directed at a place, that action is currently not a crime. As a result, the City of Orlando desires to close that loophole by making a threat against a place a crime of disorderly conduct. The issue is currently before the State legislature for consideration so the City will enact this ordinance (Ordinance No. 2018-16) relating to Disorderly Conduct on an emergency basis to cover the next several weeks. If this emergency ordinance is adopted today, it will become effective immediately upon Mayor Dyer's signature.

At approximately 3:05 P.M. Mayor Dyer recessed the City Council meeting and convened the Community Redevelopment Agency (CRA) meeting.

4. Community Redevelopment Agency (CRA)

Mayor Dyer called on CRA Executive Director Thomas Chatmon to present the following item:

(1) Approving Parramore Oaks-Second Amendment to Development Agreement between City of Orlando, Community Redevelopment Agency (CRA) and InVictus Development, LLC (InVictus). Mr. Chatmon stated that in December 2016, the CRA entered into Purchase and Sale Agreements (Phase 1 and Phase 2) and a Development Agreement with InVictus Development, LLC for the development of 211 mixed-use apartment units, named Parramore Oaks, on property owned by the City and CRA. Mr. Chatmon stated that InVictus obtained 9% Low Income Housing Tax Credits (LIHTC) through the Florida Housing Finance Corporation (FHFC) for Phase I of the project, consisting of 120 apartments. At approximately 3:07 P.M. Chief Assistant City Attorney Kyle Shephard briefly left the meeting and returned at 3:07 P.M. Mr. Chatmon further stated that the item before the CRA today is for the remaining 92 apartment units. The CRA Advisory Board (CRAAB) is requesting CRA approval of the Second Amendment to Development Agreement between the City of Orlando, CRA and InVictus Development, LLC, including an affordable housing incentive of \$491,400, subject to review and approval of the City Attorney's Office, and authorization for the CRA Chair and Executive Director to execute the Agreement Amendments, and authorization for the CRA Chair to sign the FHFC contribution grant form and any other necessary documents acknowledging the grant amount contemplated by the Development Agreement Amendment, as well as any other documents needed for InVictus's RFA 2018-102 application. Commissioner Samuel B. Ings asked for clarification as to an earlier commitment of \$75,000 and Mr. Chatmon answered that this Second Amendment erases that. Commissioner Regina I. Hill moved and Commissioner Patty Sheehan seconded a motion to approve the Parramore Oaks-Second Amendment to Development Agreement between the City of Orlando, the Community Redevelopment Agency and InVictus Development, LLC, and the CRA voted unanimously to approve the Amendment, filed and documentary #180226401.

At approximately 3:08 P.M. Mayor Dyer adjourned the Community Redevelopment Agency (CRA) meeting and reconvened the City Council meeting.

Mayor Dyer called on Orlando Police Chief John Mina to provide background on the proposed emergency ordinance. Discussion ensued among Commissioners. Mayor Dyer recognized Chief Assistant City Attorney Kyle Shephard who advised Mayor Dyer to order the City Clerk to place the ordinance under the Hearings/Emergency Ordinances agenda heading so that it is in the proper place on the agenda, that in order to adopt an emergency ordinance a 2/3 majority vote is necessary for approval, that a second reading of the ordinance will be held even though not required, and that if the emergency ordinance is adopted, it becomes effective immediately upon Mayor Dyer's signature. Mr. Shephard then asked Chief Mina the following questions to complete the legislative record:

Mr. Shephard: "Chief Mina, this ordinance proposes to close an existing loophole in state law. The ordinance is being presented as an emergency ordinance. In your experience, are threats like the ones described in this ordinance, threats on social media toward schools, are they currently challenging law enforcement in Florida today?

Chief Mina: "Yes."

Mr. Shephard: "Have these threats, particularly to schools, increased since the tragedy in Parkland a couple of weeks ago?"

Chief Mina: "Yes."

Mr. Shephard: "In your professional opinion as the Chief of Police, is adopting this ordinance for immediate application important to protect the public health, safety and welfare, given the current state of affairs?"

Chief Mina: "Yes."

Mr. Shephard then advised City Council that the emergency ordinance is sufficient for adoption, providing there is a 2/3 majority vote and after public hearing. Discussion ensued among Commissioners. Mayor Dyer

asked if there was any public comment on this item and the following persons appeared for comment: Curtis Hierro, appearing on his own behalf, spoke in support of Commissioner Regina I.
