1. Call to Order  
Richard Crabtree, Vice Chairman, called the meeting to order at 8:30 a.m.
2. Roll Call  
Heather Harris, Interim Board Administrator, performed roll call and determined a quorum was present.
3. Consideration of Minutes
  - a. Approval of the Minutes from June 6, 2018  
Prior to the consideration of the June 6, 2018 minutes, a motion was made by Jimmy King and seconded by Caila Coleman, to add more detail to the Citizens' Police Review Board minutes and public comments. He further recommended that the City video record the Citizens' Police Review Board meetings. The Board voted 6-1 to approve the motion, with Richard Crabtree opposing.

Jimmy King moved to accept the minutes of the June 6, 2018 meeting, as presented, and Beverly Jackson seconded the motion. The Board voted to approve the motion 7-0.

4. Public Comment

- a. T.J. Cole, member of the public, was sworn in and addressed the Board. Mr. Cole appeared as the complainant of the Internal Affairs Investigation IR 17-38 (Officer Robert Schellhorn). Mr. Cole asked for the mission statement of the Citizens' Police Review Board to be read again. Mr. Cole shared his opinion on the Board's mission statement and functionality.
- b. Lawanna Gelzer, member of the public, thanked the Citizens' Police Review Board members for their service. Ms. Gelzer also shared her opinions about the Orlando Police Department and obtaining public records from the City Clerks' Office.

5. Old Business

The Citizens' Police Review Board reviewed and discussed Letter re: IR 17-38, Internal Investigation (Officer Robert Schellhorn). No action taken at this time.

A motion was made by Caila Coleman, and seconded by Jimmy King, to hold a separate meeting for the Board to consider the wording of Letter re: IR 17-38. The board voted 5-2 to approve the motion, with Richard Crabtree and Korey Engel opposing.

Caila Coleman made a motion to the board: if the need arises to draft a letter to the Chief of Police, the Board should schedule a special meeting to compose the draft. The board voted 7-0 to approve the motion.

Dwain Rivers, Manager, Internal Affairs, presented a case summary for IR 17-64. Discussion ensued.

Richard Crabtree made a motion to accept IR 17-64, as presented, and Gerard Mitchell seconded the motion. The Board voted to approve the motion 7-0.
