Hispanic Chamber of Commerce Supplier Diversity

Available to any business member, the Supplier Diversity Council is comprised of leaders from many different private and public organizations to serve on this council and provide ideas, best practices and future contracts of projects from buyer perspective

Supplier Diversity Capacity Building Academy 2.0

Free 10-month program for established companies, not start ups with minimum of \$300,000 revenue and prepares these companies looking for contracts with public and private entities. Example: Residential Construction can take this program to learn how to transition to the Commercial Real Estate market.
