1. PUBLIC COMMENT

Ms. Laudeman asked if there was anyone from the public who wished to speak on an agenda item. There was no response. She then turned the meeting over to Mr. Stronkowsky, NEPC, to review the performance of the plans.

2. MARKET UPDATE

Mr. Stronkowsky noted the market continues to face volatility in the banking sector, and geopolitical tensions remain. He stated the market is being driven by increasing interest rates and inflation. Most of the asset classes were negative for the third quarter.

3. **PERFORMANCE UPDATE**

Mr. Stronkowsky reviewed the performance of the pension funds. The Police and Firefighters' Pension Funds returned -2.4% and -2.5%, respectively, for the quarter ending September 30, 2023. The General Employees' Pension Fund returned -3.1% for the same period. For the fiscal year ending September 30, the Fire returned 9.9% and Police returned 10.1%. General Employees' plan returned 9.4% for the same period. Mr. Stronkowsky reviewed the individual money managers performance for the quarter. Some discussion ensued.

There being no other business Ms. Laudeman adjourned the meeting at 9:38 AM.
